A RESOLUTION OF THE CITY OF MARGATE, FLORIDA APPROVING TECHNICAL REVISION TO THIRD AMENDMENT SHIP LOCAL HOUSING ASSISTANCE PLAN (LHAP) 2016-2017, 2017-2018, AND 2018-2019; PROVIDING FOR AMENDMENT TO THE DISASTER MITIGATION STRATEGY TO INCLUDE UP TO \$5,000 FOR TEMPORARY RENTAL, MORTGAGE, UTILITY, AND HOMEOWNER ASSOCIATION PAYMENT ASSISTANCE FOR ELIGIBLE RESIDENTS FINANCIALLY IMPACTED BY THE COVID-19 PANDEMIC, IN THE EVENT THAT ADDITIONAL FUNDS ARE ALLOCATED TO THE CITY UNDER THE STATE HOUSING INITIATIVES PARTNERSHIP (SHIP) PROGRAM; AUTHORIZING THE MAYOR AND CITY MANAGER TO APPROVE ANY AMENDMENTS TO THE LHAP THAT PROVIDES FOR RECEIPT OF FUNDS FROM THE STATE AND NO CHANGE OF TERMS, WITHOUT FURTHER COMMISSION ACTION; PROVIDING FOR EFFECTIVE DATE.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

**SECTION 1**: That the City Commission of the City of Margate, Florida hereby approves the Technical Revision to Third Amendment SHIP Local Housing Assistance Plan (LHAP) for program years 2016-2017, 2017-2018, and 2018-2019, to provide for up to \$5,000 of temporary rental, mortgage, utility, and homeowner association payment assistance for eligible residents financially impacted by the COVID-19 pandemic, in the event that additional funds are allocated under the SHIP program.

**SECTION 2**: That the Mayor and City Manager are hereby authorized and directed to execute any agreements and other documents necessary to implement this Technical Revision to the LHAP.

**SECTION 3:** That the Mayor and City Manager are authorized to execute any amendments to the LHAP that provide

for receipt of funds from the State of Florida and no change of terms, without further Commission action.
