Please be advised that the St Lucie West Services District ("District"), formed under Chapter 190 of the Florida Administrative Code, recently bid a project to construct its' permanent 6,656 SF office facility on the District's utility site and Sisca Construction Services, LLC ("Sisca") was determined to be the lowest and best bid with a price of \$1,576,865. The District had been operating in temporary modular offices located on the same site making decommissioning and removal of the existing modular facilities an integral part of the project and necessitating that the project be constructed in two phases.

The contract was signed in February 2020 with a 420-calendar day contract time, establishing a substantial completion date near the end of March 2021. Sisca began construction immediately following contract execution and has achieved substantial completion on Phase 1 of the project that includes the new building and small parking area. The certificate of occupancy was received on September 14th and staff is currently occupying the new building while arrangements for removal of the modular facilities are being made. Once removed, the remaining parking lot, sidewalk, lighting, and landscape improvements to support the new building can be installed, and final completion can be achieved. We expect that final completion of the project will occur late in December 2020 a full three months earlier than required by contract.

Quality of the finished product is excellent and on-site supervision, coordination and oversight provided by Sisca personnel have insured that the project stays on schedule and within the established budget.
