This Engineering Services Task Order is entered into this \_\_\_\_ day of \_\_\_\_\_\_, 2021 by and between the MARGATE COMMUNITY REDEVELOPMENT AGENCY, hereinafter referred to as "CRA" and CRAVEN THOMPSON & ASSOCIATES, INC., hereinafter referred to as "CONTRACTOR".

## WITNESSETH:

WHEREAS, the CRA and the CONTRACTOR previously entered into an Agreement for General Engineering Consulting Services dated March 9, 2016 (the "Original Agreement"); and

WHEREAS, in accordance with the Original Agreement, the Original Agreement was renewed for three consecutive one year extensions with the last extension ending March 9, 2021, with an additional 90 day extension ending June 7, 2021; and

WHEREAS, the CRA and the CONTRACTOR are authorized to enter into Task Orders in order to provide for additional services to be provided by the CONTRACTOR for the CRA, pursuant to the Original Agreement; and

WHEREAS, the CRA and the CONTRACTOR desire to enter into this Task Order in order for the CONTRACTOR to provide additional services pursuant to the Original Agreement, except as modified herein;

NOW, THEREFORE, in consideration of the mutual covenants and promises herein contained, the CRA and the CONTRACTOR agree as follows:

- 1. The "WHEREAS" clauses recited above are hereby incorporated herein by reference.
- 2. The CRA authorizes the CONTRACTOR to perform additional services as provided in this Task Order for the following CRA Project:

3. The Scope of Services for the Project, as provided in the Original Agreement, is hereby amended in order to authorize the CONTRACTOR to provide the Scope of Services as described on Exhibit "A", to this Task Order, which is attached hereto and incorporated herein by reference.

- 4. The Budget for the Project as stated in the Original Agreement is hereby amended to reflect the adjustments indicated on Exhibit "A" to this Task Order, which is attached hereto and incorporated herein by reference. The total budget for this assignment shall not exceed: Six Thousand Three Hundred Fifty Dollars (\$6,350.00). Payments shall be disbursed as provided for in the Original Agreement.
- 5. The Completion Date for the Project as stated in the Original Agreement is hereby amended to provide for the CONSULTANT to complete the Scope of Services described in Exhibit "A" to this Task Order no later than forty-five (45) days following the issuance of the Notice to Proceed. This Task Order may be extended up to an additional thirty (30) days subject to a written amendment to this Agreement executed by the Chair of the MCRA. Extensions beyond thirty (30) days require approval by the MCRA Board.
- 6. This Task Order is approved contingent upon the CRA's acceptance of and satisfaction with the completion of the services rendered in the previous phase (if any) or as encompassed in the Original Agreement, as may have been amended by any prior Task Orders entered into between the CRA and the CONTRACTOR. If the CRA, in its sole discretion, is unsatisfied with the services provided in a previous phase, or prior Task Order, the CRA may terminate the Original Agreement without incurring any further liability.
- 7. The CONTRACTOR may not commence work on any Task Order, including this Task Order, approved by the CRA, without a further notice to proceed issued in writing by the CRA Executive Director, or their authorized representative.
- 8. The Original Agreement, as may have been modified by prior Task Orders, and except as modified herein, shall remain in full force and effect.

### I. SURVEYING SERVICES

1.1 <u>Boundary and Topographic Survey</u> (CTA Task No. 11020)

Prepare a Boundary and Topographic Survey of the Serino Park Site. The Survey will meet current surveying requirements of the Board of Professional Surveyors and Mappers of the State of Florida, as outlined in Chapter 5J-17 of the Florida Administrative Code. The boundary survey will include the recovery and/or setting of property boundary monumentation. The Topographic survey will include location of aboveground visible improvements (i.e., pavement, slabs, fences, parking striping, trees, and utility features). We will obtain sanitary and storm sewer rim elevations with pipe invert elevations including size and type of pipe with direction of flow, if visible, and not obstructed. In addition to locations within the property boundary, we will also collect locations of the aboveground visible improvements to the East edge of pavement for S.R. 441. Topographic elevations will be obtained on the site at a 50-foot grid. All elevations will be based on the North American Vertical Datum of 1988 (NAVD 88) and referenced to a Florida Department of Transportation or National Geodetic Survey benchmark. The survey will be prepared in AutoCAD Civil3D, version 2017 or higher drawing file format.
