The applicant/sponsor of the event is responsible for ensuring that all individuals who look below the age of thirty (30), present proof that they are above the age of twenty-one (21) years.

2.No person shall be over served alcoholic beverages to the point of intoxication. The applicant/sponsor of the event shall be responsible to ensure the foregoing.

3.No person who appears to be intoxicated shall be served alcoholic beverages. The applicant/sponsor of the event shall be responsible to ensure the foregoing.
