2) PUBLIC DISCUSSION

CITY CLERK KAVANAGH explained the protocol for submitting a Public Discussion. He read a letter from a concerned resident regarding hate crimes on Facebook. He also read a letter from Tracy Van Winkle pertaining to various matters in the City.

JULI VAN DER MEULEN, 2913 NW 68 LN. said that the rapid cutting down of old trees in Margate needed to be addressed and read a statement on the same.

MAYOR SCHWARTZ responded to Ms. Van Der Meulen's comments.

LAURIEANNE M. MINOFF 8362 SHADOW WOOD BLVD. wanted to discuss Agenda Items.

MAYOR SCHWARTZ advised Ms.Minoff to wait until the Agenda Items were heard before making comment.

MARY DUNCAN, 6500 NW 9TH STREET discussed a noisy neighbor.

DEROLE DUNCAN continued from his wife's complaint about a noisy neighbor.

MAYOR SCHWARTZ addressed the complaint made by Mr. and Mrs. Duncan.

Discussion ensued.

LAUREN BERACHA, 6950 NW 14TH PLACE requested if the City could address speeding cars on Margate Blvd., especially by NW 66th Ave.

Discussion ensued.

3) COMMISSION COMMENTS

COMMISSIONER CAGGIANO discussed being present at the Egg Hunt. He highlighted the importance of using the Police Department's Outreach programs. He discussed the recent religious holidays. He wished former Information Technology (IT) Director, Jim Wilbur, a long and happy retirement. He highlighted that the Coronavirus disease 2019 (COVID-19) cases were spiking again and spoke of the importance of wearing a mask and scheduling a vaccine shot.

COMMISSIONER JOANNE SIMONE received positive feedback about the Police Department's non-emergency telephone line. She suggested that they should consider installing plexiglass dividers on the dais. She wished former IT Director Wilbur all the best in his retirement and said that he had been a great asset to the City.

COMMISSIONER RUZZANO asked if they could pull 5B from the Consent Agenda.

MAYOR SCHWARTZ said yes.

COMMISSIONER RUZZANO congratulated a friend who received a good doctor's report today. He referenced Norman Grad, who had a friend who needed the COVID-19 vaccination and thanked North West Focal Point Senior Center (NWFPSC) Project Director Karin Diaz and everyone else who was involved. He referenced baseball and informed that next Thursday was Jackie Robinson Day.

MAYOR SCHWARTZ advised that they also moved the deadline for filing taxes to May.

COMMISSIONER RUZZANO said that the groundbreaking for Fire Station 58 was a great success. He referenced Calypso Cove where they had a recent discussion about staff researching to either outsource or consider some sort of beer/wine to the park. He indicated that there was a good presentation from another city doing a similar initiative. He spoke about the possibility of marijuana being legalized.

Discussion ensued on medical marijuana dispensaries and the Police force.

COMMISSIONER RUZZANO referenced the Firehouse and said that the City's negotiations with Broward County should include all of their firefighters.

Discussion ensued on the Firefighter's contract with Coconut Creek.

VICE MAYOR ANTONIO V. ARSERIO questioned City Manager Curtis about seniority provisions in the current Firefighter's agreement with Coconut Creek.

CITY MANAGER CURTIS explained the Coconut Creek agreement pertaining to ranking and the probationary period.

Discussion ensued.

VICE MAYOR ARSERIO referenced COVID-19 and advised that people should continue to social distance. He highlighted Coconut Creek's Broward College for COVID-19 vaccinations. He said that he would return to City Hall for meetings once fully vaccinated.

Discussion ensued on vaccinations and transportation for people over the age of 50 at the NWFPSC.

MAYOR SCHWARTZ congratulated former IT Director Wilbur for his service and thanked Parks and Recreation for the Easter Egg Hunt, which she attended. She said that Code Red was replaced with Margate Cares. She thanked the Legacy Closet who received chocolate from the cruise lines. She thanked those who had attended today. She explained that it was the decision of the Homeowners Association (HOA) or the Condominium Association's respective boards to keep community pools closed and advised that the City's pools would be opening soon. She wished Commissioner Caggiano a Happy Birthday. She thanked Public Works and referenced cleaning catch basins.

4) CITY MANAGER'S REPORT

CITY MANAGER CURTIS provided an update on Vinson Park, referenced lighting improvements and advised that they would be scheduling a ribbon cutting for Southgate Park, which was almost complete. He said that they were excited to reopen Calypso Cove this weekend. He evaluated options for serving alcohol and outsourcing the concessions and referenced Cape Coral and said that they would present this at a future City Commission meeting. He referenced installing plexiglass on the dais in the City Chambers and requested feedback from the City Commission.

Discussion ensued including looking into the renovation of City Chambers.

CITY MANAGER CURTIS said that he would research options with Public Works for non-permanent plexiglass dividers and wished Commissioner Caggiano a Happy Birthday.

CITY CLERK KAVANAGH wished Commissioner Caggiano a Happy Birthday.

Although you must abstain from voting in the situations described above, you are not prohibited by Section 112.3143 from otherwise participating in these matters. However, you must disclose the nature of the conflict before making any attempt to influence the decision, whether orally or in writing and whether made by you or at your direction.
