SECTION 1: That the City Commission of the City of Margate, Florida, approves termination of the Agreement with the Landscape Company, Inc. for RFP No. 2016-006 City-Wide Lawn Maintenance Services - Areas "C" and "D" (primary), as awarded under Resolution No. 16-224, and approves amendment of the Agreement with the second ranked firm, Landscape Service Professionals, Inc., as awarded under Resolution No. 16-224 to include areas "C" and "D" (primary) to provide for two additional areas of service, adjusted compensation, and for all other terms and conditions to remain unchanged.

SECTION 2: That the Mayor and City Manager are authorized and directed to execute the Amendment on behalf of the City of Margate, a copy of which is attached and made a part of this Resolution.

SECTION 3: That this Resolution shall become effective immediately upon its passage.

AMENDMENT TO CONTRACT BETWEEN THE CITY OF MARGATE AND LANDSCAPE PROFESSIONALS, INC. FOR CITY-WIDE LAWN MAINTENANCE SERVICES

THIS AMENDMENT is made to the Contract between the CITY OF MARGATE, FLORIDA, a municipal corporation organized and existing under the laws of the State of Florida, whose primary place of business is located at 5790 Margate Boulevard, Margate, Florida 33063 ("CITY") and LANDSCAPE SERVICE PROFESSIONALS, INC., whose primary place of business is located at 6115 NW 77TH WAY, TAMARAC, Florida 33321 ("CONTRACTOR"), as approved by City Resolution No. 16-224 on June 1, 2016, for: RFP 2016-006 CITY-WIDE LAWN MAINTENANCE.

NOW, THEREFORE, for good and valuable consideration set forth herein, CITY and the CONTRACTOR agree as follows:

1. CITY and CONTRACTOR agree to incorporate one new service location into Area "A", and one new service location into Area "B", with the following descriptions, cut schedules and pricing:

- 2. Article 2, Scope of the Work, shall be amended to note that the area of service are Areas "A", "B", "C" and "D" and that the CONTRACOR is primary and no longer the alternate for Area "D".
- 3. Article 4, Contract Sum, shall be amended to read: 1. CITY shall pay CONTRACTOR an amount not to exceed the unit cost for each location within CONTRACTOR'S awarded areas upon its determination that work has been satisfactorily completed. The total contact amount of \$134,700.00 for Area "A" North, \$124,910.00 for Area "B" South, and Area "C" Utility Department Properties shall be based on the estimated annual service schedule as stipulated in the RFP document and/or the revised Detailed Price Tabulation Sheet. CONTRACTOR shall serve as primary contractor for Area "D" Code Related Lot Cuttings. Services for Area "D" shall be performed on an as needed basis for \$69.00 per cut, with additional maintenance services performed as needed for \$24.00 per man hour.

4. All other provisions set forth in the RFP 2016-006 City-wide Lawn Maintenance document and the original Contract approved by City Resolution No. 16-224 shall remain in full force and effect except as provided herein.

IN WITNESSETH WHEREOF, CITY and CONTRACTOR have signed this Amendment to Contract in duplicate. One counterpart each has been delivered to CITY and CONTRACTOR. All portions of the Contract Documents have been signed or identified by CITY and CONTRACTOR.
