- A. ID 2021-203** EMERGENCY ORDINANCE - AUTHORIZING THE CITY MANAGER TO MAKE PROVISIONS FOR PUBLIC MEETINGS BY USE OF COMMUNICATION MEDIA TECHNOLOGY AND FOR ATTENDANCE BY USE OF SUCH TECHNOLOGY BY ELECTED, APPOINTED OFFICIALS, STAFF, AND PUBLIC DURING PERIODS WHEN THE CITY MANAGER

DETERMINES AND DECLARES A LOCAL PUBLIC HEALTH EMERGENCY OR OTHER CIRCUMSTANCES IN WHICH THE CITY COMMISSION DETERMINES IT IS NECESSARY TO PROTECT THE HEALTH AND SAFETY OF CITY OFFICIALS, CITY STAFF, AND THE PUBLIC, FOR A 60 DAY PERIOD; PROVIDING FOR TWO-THIRDS AFFIRMATIVE VOTE REQUIRED FOR ADOPTION PURSUANT TO SECTION 3.19 - EMERGENCY ORDINANCES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

This item was heard immediately after the ROLL CALL.

MAYOR ARLENE R. SCHWARTZ amended this Item pertaining to the Executive Order regarding meetings to the public and the reopening of City Hall.

CITY MANAGER CALE CURTIS referenced Governor DeSantis' Executive Order and advised that they would no longer need to pass this Emergency Ordinance. He requested that they strike that Ordinance from the Agenda.

COMMISSIONER ANTHONY N. CAGGIANO questioned whether the public could continue to watch the City Commission meetings on Zoom.

He congratulated the City Commission and referenced a conversation with the State Association who thought it was phenomenal to keep the children healthy and active when the City sponsored the registration fees for children's team sports during the pandemic.

CHIEF OF POLICE, JON SHAW thanked the City Commission for recognizing Law Enforcement Week.

2) PUBLIC DISCUSSION

JULIE JONES, 7871 NW 1ST STREET, said that Cinco de Mayo was a day to remember to welcome the City of Margate back on their first day of reopening. She congratulated the Margate Flag Football team for winning the County title. She referenced a lack of communication between the City employees and the Board of Adjustment (BoA).

MAYOR SCHWARTZ said that she agreed with Ms. Jones' comments pertaining to the BoA.

RICH ALIANIELLO, 7631 NW 23RD STREET, said that there were many people who were helpful throughout the Coronavirus disease 2019 (COVID-19) pandemic and thanked the City.

CITY CLERK KAVANAGH explained the protocol for submitting a Public Discussion via Zoom.

ELSA J. SANCHEZ, 6930 NW 15TH STREET, welcomed the City Commission back on the reopening of the City. She congratulated and praised City Clerk Kavanagh for a very well deserved recognition and spoke highly of the service received from the staff in his office. She thanked Fire Chief Roberto Lorenzo and Fire Marshal Scholl for attending a Zoom meeting with Paradise Gardens III.

TRACY VAN WINKLE, 1020 SW 61ST AVENUE, sent her condolences to Commissioner Ruzzano for the loss of his Mother-in-Law. She said that she was very sorry that they lost a great teacher at Atlantic West Elementary. She questioned whether Public Works' employees were picking up trash throughout the City. She said that volunteers had been collecting trash.

CITY MANAGER CURTIS confirmed that they had staff that picked up trash in parks and facilities. He stated that it was the responsibility of the owners to collect trash on private property and indicated that it could be a Code issue if this was not performed. He greatly appreciated volunteers who picked up trash and referenced the Adopt-a-Street program.

Discussion ensued including trash at Southgate Park, the median on Southgate Boulevard and lights repaired at Southeast Park.

COMMISSIONER TOMMY RUZZANO responded to Ms. Van Winkle's comments on trash and referenced adding a member of staff pertaining to the same at the next budget meeting.

3) COMMISSION COMMENTS

COMMISSIONER ANTHONY N. CAGGIANO said a Happy Cinco de Mayo and that the festival of Ramadan was almost over. He highlighted the Asian American and Pacific Islander Heritage Month. He discussed mental health and requested residents to use the Margate Cares app on the City's website.

COMMISSIONER JOANNE SIMONE requested to pull Consent Agenda Items A and B.

MAYOR SCHWARTZ confirmed that those Items could be pulled.

COMMISSIONER SIMONE referenced a newspaper article about Tamarac's new initiative to help their businesses and restaurants and questioned if the City could piggyback on some of those good ideas. She wished a Happy Mother's Day for next Sunday.

COMMISSIONER RUZZANO wished everyone a Happy Mother's Day. He thanked those for coming out for the passing of his Mother-in-Law and for buying cards and flowers. He responded to Commissioner Simone's comments and the Our Margate Magazine and said that next month, he would showcase a list of local restaurants through his "Taste of Tommy" page. He referenced Facebook and thanked Vice Mayor Arserio for resolving his problem with a pool filter.

VICE MAYOR ANTONIO V. ARSERIO replied to Commissioner Ruzzano pertaining to pools. He referenced experiencing side effects upon receiving the second dose of the COVID-19 vaccine and highlighted that Broward College - North Campus, was administering the same. He thanked the public for attending the City Commission meeting in person. He congratulated Ms. Sanchez on her board appointment. He referenced an Ordinance that was on the Agenda and thanked the Realtors Association for providing input. He referenced Parks and Director Jones and requested an update on the Fields donation and the volunteer group for the community gardens/landscape input.

PARKS AND RECREATION DIRECTOR JONES provided an update on the Fields donation and referenced doing a planting project. He informed that they were in the final stage of putting the applications together for HR and advertising pertaining to the community gardens/landscape board.

VICE MAYOR ARSERIO said that he appreciated everything that the Parks and Recreation Department did in the City. He advised that the first edition of Our Margate should be hitting mailboxes shortly and said that he received positive feedback from a local media outlet who had received an early copy. He recognized Teacher Appreciation Week 2021 and also referenced Rob Reiner of Keep Our Money in Margate Group (KOMIM) and said that they both contributed to the National Parent Teacher Association (PTA) for Margate Elementary School.

MAYOR SCHWARTZ gave condolences to Commissioner Ruzzano's family. She thanked the Legacy Closet for providing chocolate that she helped deliver to schools for Teacher Appreciation Week 2021. She said Happy Mother's Day and spoke on the City's publication, Our Margate. She thanked Parks and Recreation for last Saturday's Tree Giveaway. She advised that Margate's Walmart was administering the COVID-19 vaccines. She congratulated Norma Rosenberg who was 100 years old.

COMMISSIONER RUZZANO referenced putting in the budget, an amount for the Mayor's Fitness Challenge and questioned if they could still receive the money and do what they want. He asked for CONSENSUS from the City Commission to ask City Manager Curtis to utilize the funds if needed.

Discussion ensued including the line item amount of \$5,000.

CITY MANAGER CURTIS requested authority from the City Commission to reach out to the appropriate schools to utilize the Mayor's Fitness Challenge funds as deemed appropriate.

CONSENSUS was given by the City Commission 5 – 0 to use the Mayor's Fitness Challenge funding.

4) CITY MANAGER'S REPORT

CITY MANAGER CURTIS said a Happy Mother's Day and a Happy Teacher Appreciation Week 2021. He advised that their quarterly magazine should be distributed this week and spoke on its content. He recognized Communications and Marketing Manager Maria Fallon for putting this magazine together.

COMMISSIONER CAGGIANO asked if they could have a phone directory on their website of Margate businesses based on information from the local business tax receipts (LBTR).

CITY MANAGER CURTIS said that he could look into the phone directory. He explained that he had been approached by one of their non-profit organizations, Legacy Closet, about holding a food distribution in the City and using property that Margate or the Community Redevelopment Agency (CRA) had. He requested authority to work with Legacy Closet to host a food distribution site in the City by coordinating with the CRA to allow use of the property.

CONSENSUS was given by the City Commission (5 – 0).

CITY MANAGER CURTIS advised that he would begin coordinating with the Legacy Closet.

COMMISSIONER RUZZANO thanked City Manager Curtis for what he did and referenced receiving phone calls.

CITY MANAGER CURTIS expressed his gratitude to the City Commission.

Discussion ensued.

CITY ATTORNEY SMITH thanked Broward County Planning Council (BCPC) for the recent approval of the Comprehensive Plan. She also provided an update on New Urban being remanded back to the State Court. She sent her condolences to the Ruzzano family. She wished everyone a Happy Mother's Day. She asked the City Commission if they desired additional research on a potential Ordinance to address egregious outbursts at public meetings with a financial penalty.

COMMISSIONER RUZZANO said that former Margate resident, Mr. Popovic, congratulated the City on the New Urban reversal. He also spoke against City Attorney Smith's proposal of a City Ordinance to address egregious outbursts at public meetings.

Discussion ensued on the proposed Ordinance.

CONSENSUS was given by the City Commission (4 – 1 – Commissioner Ruzzano NO) for the City Attorney to research the Ordinance further and provide a future update.

VICE MAYOR ARSERIO referenced the Governor DeSantis' Emergency Order and asked what format Public Comments could be received in.

MAYOR SCHWARTZ thought there was something in the rules and procedures that a person who wanted to speak was required to be recognized.

VICE MAYOR ARSERIO discussed Facebook and said that it was a very valuable tool. He discussed a recent post pertaining to boats and trailers parked on properties and

referenced the Code re-write.

CITY CLERK KAVANAGH said Happy Mother's Day and gave his condolences to the Ruzzano family. He thanked the City Commission again for presenting the Municipal Clerks Week proclamation.

ORDINANCE 2021-4

Mayor Schwartz suggested moving up items 8A, 8C and 9A to be heard.

A motion was made by Commissioner Caggiano, seconded by Commissioner Simone, that this Ordinance, Second Reading, should be discussed.

VICE MAYOR ARSERIO spoke on this Item and thanked the Broward, Palm Beaches and St. Lucie Realtors for contacting the City Commission and providing input.

COMMISSIONER TOMMY RUZZANO asked whether a registration fee would scare people away and referenced too much red tape.

CITY MANAGER CURTIS said that by adopting this Ordinance, they would be required to register their rental property and that it was not a voluntary program.

Discussion ensued including fees, multi-owner properties, water bills, homestead fraud, renting parts of the home such as a garage and landlords.

BROWARD, PALM BEACHES AND ST. LUCIE REALTORS SR. VICE PRESIDENT OF PUBLIC POLICY & EXTERNAL AFFAIRS, ADAM I. SANDERS, explained that they believed in private property rights and discussed community expectations.

Discussion ensued.

MS. SANCHEZ spoke in favor of this program and referenced Paradise Gardens III.

Discussion ensued including bylaws.

PROCHAMPS' NATIONAL GOVERNMENT RELATIONS DIRECTOR AT PROPERTY, SCOTT BLASIE gave kudos to City staff and addressed tenancy safety and welfare.

Discussion ensued including the procedure of home inspections for tenants.

MS. VAN WINKLE sought full clarification of this Item.

Discussion ensued.

BROWARD, PALM BEACHES AND ST. LUCIE REALTORS VICE CHAIR OF THE GOVERNMENT AFFAIRS COMMITTEE, LAURIEANNE M. MINOFF, 8362 SHADOW WOOD BLVD referenced the fees and the possibility of doing a sworn Affidavit on a yearly basis after the first inspection.

A motion was made by Commissioner Caggiano, seconded by Commissioner Simone, that this Ordinance, Second Reading, should be approved.

CITY MANAGER CURTIS explained that this was another registration program which was specific to abandoned and foreclosed properties and those who would be affected by this Item.

PROCHAMPS' NATIONAL GOVERNMENT RELATIONS DIRECTOR AT PROPERTY BLASIE advised that the City already had a foreclosure registration program in place and by the nature of the Ordinance, the language was highly ineffective.

Minoff, she informed him that one of their concerns was regarding the annual recurring inspection fee. He proposed that if a person had two or three Code violations, then they should consider charging them an annual fee.

Discussion ensued including the annual fee, inspection and Code violations.

BROWARD, PALM BEACHES AND ST. LUCIE REALTORS VICE CHAIR OF THE GOVERNMENT AFFAIRS COMMITTEE MINOFF said that she could see both sides and referenced Vice Chair Arserio's proposal and Coral Springs' landlord registration fee.

An amendment was made by Vice Mayor Arserio, seconded by Commissioner Ruzzano, to provide for an inspection fee in the first year and allow the submission of an affidavit of compliance with no fee for the subsequent years; if the owner was found to not be in compliance, then the inspection fee would be charged.

Discussion ensued.

COMMISSIONER RUZZANO requested everyone to read the back-up and indicated that this initiative was to encourage adults to stay at the waterpark. He said that he did not think it was a bad thing and that they should look at it with an open mind.

COMMISSIONER SIMONE explained why she was not in favor of this Item and suggested holding "adults only" themed nights at Calypso Cove.

Discussion ensued.

CITY MANAGER CURTIS explained how they put this program together and said that it was safe and had limitations.

COMMISSIONER CAGGIANO voiced his concerns over liability and lives. He also referenced selling alcohol at the Moon Under the Margate and questioned if the legal liability was different to that being proposed at Calypso Cove.

CITY ATTORNEY SMITH indicated that there would be additional insurance on top of insurance for an event such as Moon Under the Margate. She also discussed contributory negligence.

Discussion ensued on the City's liability.

PARKS AND RECREATION DIRECTOR JONES confirmed that coolers, outside food and beverages were not prohibited into the facility.

MS. VAN WINKLE spoke in opposition of this Item.

COMMISSIONER RUZZANO reiterated that it was not hard liquor but two or three wine based drinks and indicated that the objective was to bring in more revenue.

VICE MAYOR ARSERIO referenced people who drank before or brought flasks into Calypso Cove and said that the bartender could utilize discretion when serving drinks. He informed that there was liability on the bartender to serve drinks.

Discussion ensued including refusing to serve intoxicated customers, the Trespass Ordinance and personal accountability.

MAYOR SCHWARTZ asked about the estimate from the presentation, increasing park attendance by 10 percent and voiced her concerns about gross income.

Discussion ensued including ordering items from a concession stand.

MS. SANCHEZ opposed this Item.

LAUREN BERACHA, 6950 NW 14TH PLACE disagreed with any type of alcohol being served.

CITY CLERK KAVANAGH read an email dated April 21, 2021, submitted by Eddie and Theresa DeCristofaro, who expressed their deep concern of beer and wine being served at Calypso Cove and referenced liability.

MAYOR SCHWARTZ recommended that on a trial basis, they should reduce the three drink maximum to two. She agreed with the slushie machine for children.

Discussion ensued.

MAYOR SCHWARTZ asked for CONSENSUS to install a slushie machine for children.

CONSENSUS was given by the City Commission.

Discussion ensued.

An amendment was made by Mayor Schwartz, seconded by Commissioner Caggiano, to allow a two drink maximum.

Discussion ensued.

CITY MANAGER CURTIS advised that the AMENDMENT did not need to be made at this time.
