CHIEF OF POLICE, JON SHAW, spoke on this Item and presented Police Sergeant Kostic with a plaque.

Discussion ensued.

CITY CLERK JOSEPH J. KAVANAGH, spoke about the contributions to the City made by City Receptionist Perry.

CHIEF OF POLICE, JON SHAW, spoke on this Item and presented Police Officer Tindall, with a plaque.

### 2) PUBLIC DISCUSSION

MAYOR SCHWARTZ, read a statement pertaining to rules and public decorum during Public Discussion.

RICH ALIANIELLO, 7631 NW 23RD STREET, wished everyone a happy and safe Summer. He questioned whether Calypso Cove was \$500,000 in debt. He asked whether any negotiations took place with Coconut Creek pertaining to the Fire Rescue-Emergency Medical Services (EMS) which he discussed at the last City

Commission meeting.

CITY MANAGER CALE CURTIS clarified that Margate provided Fire Rescue-EMS to Coconut Creek and that the City was under an agreement with them until September 30, 2021. He confirmed that Coconut Creek opted not to renew that agreement with the City. He said that the City's Fire Rescue-EMS would stay put which would not affect service from October 1, 2021.

Discussion ensued on the partnership with Coconut Creek's Fire Rescue-EMS.

NINA CULVER, 6480 NW 11 ST., read a statement thanking Commissioner Simone and Department of Environmental and Engineering Services (DEES) Director Keyser pertaining to a Florida Power & Light Company (FPL) issue. She also thanked Vice Mayor Arserio and highlighted a City-wide school supplies drive.

### 3) COMMISSION COMMENTS

COMMISSIONER ANTHONY N. CAGGIANO thanked everyone who attended and assisted in the July 4th events.

COMMISSIONER JOANNE SIMONE congratulated all their employees for their dedicated years of service. She congratulated Margate Middle for winning its first boys basketball County championship and Abundant Life Christian Academy for winning the elementary sports league championship in soccer. She addressed the departure of former City Attorney Smith.

COMMISSIONER TOMMY RUZZANO thanked Mr. Alianiello and discussed Calypso Cove. He said that he received many calls about the condition of the canals in Margate and repeated his request for a boat ride to inspect the same. He said that he had a meeting with a Coconut Creek representative pertaining to the Fire Rescue-EMS.

VICE MAYOR ANTONIO V. ARSERIO thanked those who attended the July 4th events. He also referenced listening to a meeting pertaining to the Broward County Sheriff Office (BSO).

MAYOR SCHWARTZ discussed a meeting she attended at Cooper City which was one of 13 cities that had a fire and/or police contract with BSO. She explained that the meeting addressed concerns over a lack of transparency, staffing, costing and unanswered telephone calls amongst a multitude of other issues regarding BSO. She indicated that they would have to review the BSO situation. She reassured residents that from October 1, 2021, they would be fully covered pertaining to Fire Rescue-EMS. She wished everyone a happy Summer break and that the City Commission would return at the end of August. She introduced Interim City Attorney Tolces. She congratulated employees for their years of service.

### 4) CITY MANAGER'S REPORT

CITY MANAGER CURTIS referenced the meeting in Cooper City pertaining to BSO and explained that the City had been negotiating with BSO's Fire Rescue-EMS for approximately one year and he continued to provide an update on the same. He clarified by saying that the City was in no need to make any quick transition with Coconut Creek leaving and that Margate was in fine shape with Fire Rescue-EMS. He received notice that the City finally received the \$200,000 matching grant reimbursement for Firefighters Park which pertained to renovations that dated back to 2016.

INTERIM CITY ATTORNEY DAVID N. TOLCES introduced himself and said that he looked forward to working with everyone.
