That pursuant to Chapter 11 of the Code of Ordinances of the City of Fort Lauderdale, the City of Fort Lauderdale Special Magistrate, 100 North Andrews Avenue, Fort Lauderdale, Florida 33301, hereby enters its Order based on the following findings of fact and conclusions of law. That the Special Magistrate did issue on the 20<sup>th</sup> day of August 2015, a Final Order in the above captioned case commanding the above name respondents(s) to bring the violations specified in said Final Order into compliance on or before the 1<sup>st</sup> day of October 2015, or pay a fine in the amount of \$50.00 per day for the violation of FBC (2010) 105.11.2.1.
- 3. On April 21, 2016, the Special Magistrate found that the respondent(s) did not comply with the Final Order and any subsequent orders on or before the date specified therein, based on the testimony and evidence as presented. The respondent did comply with the Final Order on the 28<sup>st</sup> day of October, 2015. The Special Magistrate, on the 21<sup>st</sup> day of April 2016, did impose a fine in the amount of \$1,300.00.
- 4. It is the order of the Special Magistrate that the fine specified in said Final Order is hereby confirmed and ratified, plus the recovery of reasonable attorney's fees in any foreclosure of the lien.
- 5. The City shall record a certified copy of this Order in the Public Records of Broward County. Once recorded, this Order shall constitute a lien on the subject property as well as on any other real or personal property owned by the Respondent.
