1) PRESENTATION(S)

A. <u>ID 2021-335</u> 10TH ANNUAL ACADEMIC SCHOLARSHIPS BY CITY OF MARGATE, IN PARTNERSHIP WITH WASTE MANAGEMENT

(Awarded to Jetty Porter, enrolled at University of Miami, and Matthew Miller, enrolled at Embry Riddle Aeronautical University)

2) PUBLIC DISCUSSION

DISTRICT PRESIDENT FOR CITY OF MARGATE FIRE FIGHTERS, LIEUTENANT KEVIN DELACOVA, read a statement explaining why the City should rethink and revisit the contract talks with the Broward Sheriff's Office (BSO).

COMMISSIONER TOMMY RUZZANO responded to Lt. DeLaCova's comments and highlighted his concern over the cost of BSO's contract.

MAYOR ARLENE R. SCHWARTZ discussed a recent Cooper City meeting pertaining to BSO.

Discussion ensued.

VICE MAYOR ANTONIO V. ARSERIO spoke on this matter. He suggested that Mayor Schwartz could send a letter to BSO.

Discussion ensued on the meeting that took place in Cooper City with BSO contracted municipalities and the Fire Department situation between Coconut Creek and Margate.

JOHN HALL, 6421 FRENCH ANGEL TERRACE, said that this was his 10th annual visit to stand before the City Commission and repeated his request for some assistance in solving the traffic problem near a school in Coral Bay.

COMMISSIONER RUZZANO responded to Mr. Hall's comments. He believed that this matter needed to be addressed.

VICE MAYOR ARSERIO addressed Mr. Hall's comments.

MAYOR SCHWARTZ explained that she hoped that something would have been done after speaking with Coral Springs' Mayor Brook last year.

Discussion ensued.

CITY CLERK JOSEPH J. KAVANAGH read an email from Mitchell Pellecchia, 6890 NW 9th Street, which highlighted unused marked City cruisers, awarding overtime to Police Officers and speed limits in Margate's roads and referenced the issue of tickets.

TRACY VAN WINKLE, 1020 SW 61ST AVENUE questioned the lack of presence of Police Officers directing traffic by Margate schools and highlighted the long lines.

CITY MANAGER CALE CURTIS responded to Ms. Van Winkle's concerns and explained that there was a shortage of bus drivers.

COMMISSIONER RUZZANO responded to Ms. Van Winkle's concerns.

COMMISSIONER ANTHONY N. CAGGIANO discussed the school traffic.

Discussion ensued on the traffic.

3) COMMISSION COMMENTS

COMMISSIONER CAGGIANO asked drivers to be careful with kids on the roads.

COMMISSIONER RUZZANO echoed Commissioner Caggiano's comments on children returning to school and wished everyone the best.

VICE MAYOR ARSERIO asked everyone to be safe, social distance, wear a mask and encouraged people to get vaccinated.

MAYOR SCHWARTZ referenced children walking home from school and requested drivers not to park over the sidewalk. He questioned the City Manager for the next steps on the City's canals. She forewarned that there would be a very large Police presence by Abundant Life on Friday due to a funeral for Fort Lauderdale Officer Sepot.

CITY MANAGER CURTIS provided an update on the City's canals.

COMMISSIONER CAGGIANO said that a ticket of \$183.50 could be issued at a "no stopping" sign in a front of a school.

CITY MANAGER CURTIS expressed his sincere condolences to the Sepot family. He was excited to announce the return of live music in the City's downtown area from September which would be held on the first Saturday of every month.
