A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING WAIVING OF BIDDING FOR THE SOLE SOURCE PURCHASE OF AQUAHAWK 607A BULK LIQUID COAGULANT FROM HAWKINS, INC. FOR THE DEPARTMENT OF ENVIRONMENTAL AND ENGINEERING SERVICES (DEES) FOR THE ESTIMATED AMOUNT OF \$300,000 PER YEAR; PROVIDING FOR ONGOING PURCHASE SO LONG AS THE VENDOR REMAINS THE SOLE SOURCE FOR THE ITEM SPECIFIED; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Department of Engineering and Environmental Services ("DEES") is responsible for the collection, transmission, and treatment of all sanitary sewage within the City; and,

WHEREAS, DEES has recently completed construction of a new coagulant feed system in its West Wastewater Plant and requires bulk liquid coagulant to make that system operate; and,

WHEREAS, DEES staff, after extensive testing, has determined Aquahawk 607A bulk liquid chemical coagulant, to be the optimal product for the new coagulant feed system; and

WHEREAS, Hawkins, Inc. is the manufacturer and sole source provider of Aquahawk 607A bulk liquid chemical coagulant; and,

WHEREAS, several variables will necessitate the amount of this chemical to be utilized to be adjusted regularly and that annual cost is therefore estimated at \$300,000; and

WHEREAS, Section 166.021(1), Florida Statutes, provides that municipalities "may exercise any power for municipal purposes except as otherwise provided by law"; and,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA, THAT:

Section 1: The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct, and incorporated herein by this reference.

Section 2: The City Commission of the City of Margate, Florida approves the waiving of bidding for the sole source purchase of Aquahawk 607A bulk liquid coagulant from Hawkins, Inc, for so long as the vendor remains the sole source vendor for this item.

SECTION 3: This Resolution shall become effective immediately upon its passage and adoption.
