A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING WAIVING OF BIDDING FOR SOLE SOURCE PURCHASE OF JAEGER POLYPROPYLENE MEDIA PACKING FROM TSC-JACOBS, INC., FOR THE ODOR CONTROL TOWERS AT THE WASTEWATER TREATMENT PLANT, IN AN AMOUNT NOT TO EXCEED \$36,500; PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Department of Environmental and Engineering Services ("DEES") is responsible for the collection, transmission, and treatment of all sanitary sewage within the City; and,

**WHEREAS**, the packing media in the (2) odor control towers in the wastewater treatment plant is well beyond its 10-year service life expectancy and is due for replacement; and

**WHEREAS**, Raschig, USA, Inc. is the sole manufacturer of genuine Jaeger Tri-Packs plastic random packing media used in the odor control towers; and,

**WHEREAS**, TSC-Jacobs, Inc. is Raschig USA Inc.'s sole source distributor for municipal businesses in Broward County, Florida; and,

**WHEREAS**, TSC-Jacobs, Inc. is already an approved sole source provider for other water and wastewater materials, including WEMCO Specialty Pumps products and Pulsafeeder Pumps parts and service; and,

**WHEREAS**, Section 166.021(1), Florida Statutes, provides that municipalities "may exercise any power for municipal purposes except as otherwise provided by law"; and,

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA, THAT:**

**Section 1:** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and incorporated herein by this reference.

**SECTION 2:** The City Commission of the City of Margate, Florida approves the waiving of for the sole source purchase of genuine Jaeger Tri-Packs plastic random packing media from TSC-Jacobs, Inc.

**Section 3:** That the Mayor and City Manager are authorized and directed to execute a contract for the above, or the administration is authorized to issue a purchase order to implement same.

**SECTION 4:** This Resolution shall become effective immediately upon its passage and adoption.
