#### 2) COMMISSION COMMENTS

COMMISSIONER LESA PEERMAN said that she was in Tallahassee when the Marjory Stoneman Douglas High School shooting happened. She discussed the tragedy in Parkland and the impact of the students in Tallahassee and Washington, DC. She asked for CONSENSUS asking the Mayor to send a letter to the City's State Representatives to support "Common Sense" gun laws. She also discussed the age limit to purchase fire weapons.

COMMISSIONER JOANNE SIMONE said that the Sunrise gun-related Resolution was very well written and basically covered everything and asked if they could do something similar.

COMMISSIONER TOMMY RUZZANO questioned whether Cities could discuss gun regulation. He said that Sunrise's Resolution was too strict.

CITY ATTORNEY JAMES A. CHEROF said that Cities could not regulate what was pre-emptied by the state but could weigh in on many types of issues similar to the type of Resolution that Sunrise had circulated to review and adopt.

VICE MAYOR ANTHONY N. CAGGIANO discussed the Parkland tragedy and suggested sending a letter to the City of Parkland, as well as the State Legislators.

CITY ATTORNEY CHEROF said that he would draft a Resolution similar to Sunrise with alternative wording and bring it back to the Commission.

COMMISSIONER SIMONE received great feedback for DEES and City employees. She discussed walkways and bike paths, including the Complete Streets program. She praised the City Staff and said that they were wonderful professionals. She also mentioned adding a Resolution to the next Agenda regarding adding the words "In God We Trust" in the Commission Chambers.

COMMISSIONER RUZZANO discussed Margate becoming the first "Ring" City in the United States, which is a doorbell video monitoring device.

Discussion ensued.

COMMISSIONER RUZZANO mentioned the Challenger Baseball event on Sunday, February 25th from 2:00pm to 5:00pm. He discussed the tragedy in Parkland and requested suggestions on how they could improve safety in Margate's schools.

VICE MAYOR CAGGIANO discussed making Margate being the safest City possible. He advised that the Margate Garage Sale would take place on March 17th.

COMMISSIONER PEERMAN highlighted the following events:

- Absolute Surplus Auction on Saturday February 24th on Rock Island and 1st Street.
- Movies in the Park on February 24th.

#### 3) PUBLIC DISCUSSION

JULIE JONES, 7871 NW 1ST STREET discussed the Parkland tragedy and gun control.

BARRY S. GLUCK, 7921 NW 29TH STREET explained that he represented a grass roots community group called Parents Against School Shootings (PASS), discussed the Parkland tragedy and read a statement.

Discussion ensued regarding school security ideas.

CITY ATTORNEY CHEROF said he would research how the City can regulate private school security.

JILL R. CERCHIONE, 6188 SEMINOLE TERRACE said that she was the owner of Michelle's International Learning House and said that she was at the meeting on behalf of all early childcare education centers. She discussed the Parkland tragedy and childcare center lockdown protocol. She requested her business to be informed when lockdown situations occur near her facility.

Discussion ensued regarding the Code Red program being implemented and reaching out to Margate childcare centers.

CITY MANAGER MAY mentioned implementing a robocall system regarding lockdowns. He also said that he would get back to Ms. Cerchione pertaining to Code Red.

POLICE CHIEF DANA WATSON discussed the School Board of Broward County protocol for lockdowns.

MARK ROBINSON, 2450 BANKS ROAD explained that he worked for Liberty Elementary and discussed the Parkland tragedy and school safety at Liberty Elementary.

VICE MAYOR CAGGIANO asked about talking to Broward County Schools about ideas.

CITY ATTORNEY CHEROF said a Resolution or letter could be sent to the School Board.

Discussion ensued regarding sending a letter of suggestions to the School Board.

ANDREW ROSENGARTEN, 6770 NW 15TH STREET explained Florida's conditional approval on purchasing firearms. He also questioned the root cause of tragedies such as the incident that occurred in Parkland and how security measures could be improved.

STANLEY LEWIS, 5160 SW 8TH STREET discussed a Youth Football Tackle program trying to merge together North Lauderdale and Margate. He said that they were not asking for any funds.

CITY MANAGER SAM A. MAY asked Mr. Lewis to leave his number with the City Clerk.

DANNY MARINO, 2600 NW 69TH AVENUE said that he lived in the Carolinas and liked Commissioner Ruzzano's "Ring" idea. He discussed burglaries in his development and school security.

TONY SPAVENTO, 3194 WEST BUENA VISTA DRIVE discussed school security, gun control and what topics should be discussed at City meetings.

He advised that construction had commenced at Dandee Donuts on the corner of State Road 7 and NW 31st Street. He said that they were finalizing their canal debris clean-up from Hurricane Irma. He said that Absolute Surplus Auction was at Public Works on February 24th.

CITY CLERK JOSEPH J. KAVANAGH sought clarification from the Commission on drafting a letter for the legislation on gun control or bringing back a Resolution.
