A. [ID 2018-405](#) PUBLIC HEARING ON PROPOSED MILLAGE RATE AND BUDGET

MAYOR ARLENE R. SCHWARTZ opened the Public Hearing at 6:12 p.m. No comments were made by the public. Public Hearing was closed at 6:13 p.m.

2) RESOLUTION(S)

A. [ID 2018-431](#) APPROVING THE MILLAGE RATE FOR THE CITY OF MARGATE FISCAL YEAR 2018/2019 IN THE AMOUNT OF 7.0593 MILLS PER THOUSAND DOLLARS OF ASSESSED VALUATION (WHICH INCLUDES .4999 FOR VOTED DEBT SERVICE); THAT THE OPERATING MILLAGE RATE OF 6.5594 IS 8.55% HIGHER THAN THE ROLL-BACK RATE OF 6.0426.

[ID 2018-434](#) ADOPTING AN OPERATING BUDGET FOR THE CITY OF MARGATE, FLORIDA, FOR THE PERIOD BEGINNING OCTOBER 1, 2018, AND ENDING SEPTEMBER 30, 2019; PROVIDING FOR A BUDGET FOR THE GENERAL FUND, SPECIAL REVENUE FUNDS, DEBT SERVICE FUND, CAPITAL PROJECTS FUND, ENTERPRISE FUNDS, AND INTERNAL SERVICE FUND; PROVIDING FOR A MILLAGE RATE; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

ORDINANCE 2018-5 was approved at 6:29 p.m.

CONSENSUS was made that the Grants Manager's position should not be moved to Development Services.

CITY MANAGER SAMUEL A. MAY confirmed that the Commission would receive a monthly report and that 50 percent of the grants work would be incorporated into the approved Contracts Administrator position.

The motion carried by the following vote:



Should any representation be false or should said representation not be continued as represented, same shall be deemed a violation of the permit and a violation of this section.
