2) COMMISSION COMMENTS

COMMISSIONER JOANNE SIMONE provided an update from The Metropolitan Planning Organization (MPO) project list which included conducting street assessments on select corridors. She explained that they wanted feedback from the community on how to implement improvements to Southgate Boulevard for their residents and students. She encouraged residents, businesses, schools and Police who were in that corridor to provide their input by attending the Galaxy Skateway on May 23rd. She thanked the City employees for taking care of their residents on a daily basis.

COMMISSIONER ANTONIO V. ARSERIO advised that Broward County implemented a new safety feature of "Text to 911". He requested to move Resolution Item 6E to the beginning of the Resolutions and asked to be excused thereafter.

CONSENSUS given by City Commission to move Item 6E to the beginning of the Resolutions.

COMMISSIONER ARLENE R. SCHWARTZ congratulated returning and new Board members for the Board of Adjustment (BoA) and Planning and Zoning Board (P&Z) and thanked those candidates who applied. She said that as Daylight Savings had started, she discussed safety and parking cars across the sidewalk under the American with Disabilities (ADA) Act. She asked for a date for a retreat with staff.

MAYOR ANTHONY N. CAGGIANO advised that no date had been arranged but he was working with the City Manager on an agenda.

COMMISSIONER SCHWARTZ discussed social media comments.

VICE MAYOR TOMMY RUZZANO advised that the Southeast Park renovations started recently which would take approximately two months to complete. He congratulated both the BoA and P&Z and spoke about Code. He discussed Code concerns about Culvers Restaurant, the Dandee Donuts Factory and the possibility of a movie theatre opening in Margate. He suggested employing an architect to help with the City Code.

MAYOR CAGGIANO recommended the Dandee Donuts Factory. He said that Kenneth A. Gibson, who was the first African American Mayor of New Jersey and father of former Commissioner Joyce Bryan, passed away recently. He sent birthday wishes to former Commissioner Joseph Varsallone.

MAYOR CAGGIANO echoed Commissioner Schwartz comments on safety and asked people to be careful with children playing on the street.

3) PUBLIC DISCUSSION

ARTHUR J. KRELL, 6117 EDWARDS ROAD discussed violations and Abatement Orders made against his property.

CHARLIE ARTNER, 6631 NW 22ND COURT discussed the recent Community Redevelopment Agency (CRA) meeting. He referenced Development Services Director, Robert J. Massarelli's comments pertaining to the law about preparing for developmental growth and highlighted his concerns. He suggested that staff could work with the residents and request the County and State to stop forcing growth.

RICH POPOVIC, 6066 WINFIELD BOULEVARD discussed CRA's accomplishments and said that the Ace Plaza looked nice. He referenced not paying Attorneys for further representation and discussed the CRA. He questioned the disappearance of the Carnival.

JULIE JONES, 7871 NW 1ST STREET thanked the Commission for her appointment on the BoA. She apologized to Commissioner Schwartz and Vice Mayor Ruzzano pertaining to social media comments. She highlighted a rat infestation problem. She recommended that City staff and Commission sign up to the Combat Auto Theft (CAT) program.

COMMISSIONER SCHWARTZ explained that the CAT program allowed the Police to stop your car after 1:00am in the street to find out if you were the owner of the vehicle.

Discussion ensued on the CAT program.

RICH ALIANIELLO, 7631 NW 23RD STREET wished former Commissioner, Joseph Varsallone, a Happy Birthday. He highlighted problems with residential parking at weekends and also discussed works carried out on Royal Palm Boulevard.

ELSA J. SANCHEZ, 6930 NW 15TH STREET discussed a Facebook post from Commissioner Arserio.

TONY SPAVENTO, 3194 W. BUENA VISTA DRIVE asked the Board to censure Commissioner Arserio for his behavior on social media. He also discussed the recent P&Z Board meeting and referenced electing a Chair. He also referenced photometrics and said that he offered this service free to his customers.

LAUREN BERACHA, 6950 NW 14TH PLACE discussed Facebook comments and referenced Sam May. She also referenced transparency and discussed a Commissioner's wife being appointed on one of the Boards.

TERESA DECRISTOFARO, 6600 BRANDYWINE DRIVE said that she saw the difference that Mayor Caggiano was trying to make in the City. She said she appreciated City employees who took pride in their jobs. She said that she did not appreciate the atmosphere that had been created in Margate and said that it needed to stop. She indicated that she was glad and felt confident when Samuel A. May was made the City Manager and highlighted his good work through Hurricane Wilma.

MANNY LUGO, 1129 EAST RIVER DRIVE discussed the complaint being made about one of the Commissioner's wife being appointed on the Board.

Discussion ensued.

LESA B. PEERMAN, 6921 NW 4TH PLACE discussed transparency and referenced the Commissioner's wife being appointed. She also discussed social media comments.

COMMISSIONER SCHWARTZ discussed social media comments.

ROBERT VARSALLONE commended the whole Commission and Lesa Peerman on behalf of his father.

CITY MANAGER SAMUEL A. MAY explained that they would need to provide their Consultant with a ceiling for the Fire Assessment preliminary rates. He advised that the current rate was \$300 and the maximum rate, as per the study, was \$367.

Discussion ensued.



Should any representation be false or should said representation not be continued as represented, same shall be deemed a violation of the permit and a violation of this section.
