1) PRESENTATION(S) - Continued

- C. [ID 2019-564](#) RECYCLING PRESENTATION BY WASTE MANAGEMENT.

GOVERNMENT AFFAIRS MANAGER OF WASTE MANAGEMENT BARBARA
HERRERA OF 2700 WILES ROAD, POMPANO BEACH gave a presentation on
recycling. Her discussion included recycling the right way and indicated that the City
recycled approximately 3,600 tons per year and as of October 29, year to date
contamination was about 46.8 percent. She discussed where they were with the City,
how they could improve on delivering the information on recycling and what improvements
could be made to ensure that the recycling program was a success. She referenced
"wishcycling" and advised that the markets had changed from what was currently
acceptable to that of five years ago. She advised that she would make sure the City staff
had a copy of her presentation. She encouraged the City Commission to attend an audit
of the materials at the Deerfield Beach facility.

Discussion ensued including contamination, auditing, volunteers, proposing a Workshop,
the City's educational campaign and other related topics.

RICHARD ZUCCHINI, 380 LAKEWOOD CIRCLE E, #B provided suggestions for Waste
Management including uploading a video through social media and the introduction of
clear container carts for recycling.

RICH POPOVIC, 6066 WINFIELD BOULEVARD indicated that when the contract was
signed, Waste Management was going to keep a device in the recycling bins to monitor
trash.

GOVERNMENT AFFAIRS MANAGER OF WASTE MANAGEMENT, LUIGI PACE AND
BARBARA HERRERA responded to the comments made.

CITY MANAGER CALE CURTIS said that Mr. Zucchini provided great suggestions. He
advised that their staff had produced a video of one of the weekly audits that were
performed in Margate which was on the City's Facebook page.

2) PUBLIC DISCUSSION

JULIE JONES, 7871 NW 1ST STREET thanked everyone involved in Trunk or Treat and said it was absolutely awesome and a fabulous attendance. She congratulated Commissioner Arserio on his first year anniversary of being elected. She asked the Chief of Police Shaw for advice on finding pets.

CITY MANAGER CURTIS said that he would get with Chief of Police Shaw and then work with Ms. Jones.

Discussion ensued.

DELTA SIGMA THETA SORORITY, INC. BROWARD COUNTY ALUMNAE CHAPTER SANDRA KING gave a brief overview of the organization and said that their platform was public service and that they wanted to join forces with the City.

MAYOR ANTHONY N. CAGGIANO requested Ms. King to leave her information with the City Clerk.

JULI VANDERMEULEN, 2913 NW 68 LN. highlighted a Margate 6.1 Ordinance that designated a bird sanctuary as well as a wildlife sanctuary and discussed the same. She questioned what could be done to protect wildlife.

MAYOR CAGGIANO advised that the City Attorney and City Manager would need to review this.

Discussion ensued including the City's Ordinance and trappers.

JEAN E. KAPLAN, ORIOLE GARDENS PHASE II thanked the City for helping them with the developers.

MR. POPOVIC discussed the bathroom at one of the City's parks, bonds and speeding in neighborhoods.

BARBARA ALBRECHT, ORIOLE GARDENS II read a poem on "Keep Margate Green".

PETA ZUNE, ORIOLE GARDENS II discussed Lennar Homes and other potential developers pertaining to Margate Executive Golf Course.

CITY MANAGER CURTIS confirmed that a meeting was held with the owner of the Executive Golf Course, Mr. Fimiani and City staff and explained that he offered two unfavorable options to the City.

Discussion ensued.

MARILYN A. KNEELAND, 7955 NW 5TH CT, ORIOLE GARDENS PHASE II discussed Lennar Homes stepping away from the Executive Golf Course. She also discussed the value of the property and referenced two parcels. She complimented the City's parks. She requested better communications pertaining to the Executive Golf Course.

Discussion ensued on the City's owls.

RICH ALIANIELLO questioned the value of the Golf Course.

CITY MANAGER CURTIS' approximated value was \$8,000,000 - \$9,000,000.

Discussion ensued on the golf course's property value and rezoning.

MR. ZUCCHINI referenced projects and a pre-application conference and requested that the Commission and Planning and Zoning (P&Z) have access to the City's new software. He also questioned if anyone had investigated whether there were any Federal State or County grants that were available to remediate toxic land and referenced Palm Lakes Golf Course.

3) COMMISSION COMMENTS

COMMISSIONER JOANNE SIMONE discussed and thanked the staff who were involved in the two fabulous City events of the Fall Festival and Trunk or Treat. She highlighted the forthcoming Veterans' Day ceremony and the implementation of the electronic speed limit sign on Rock Island Road by the Carolinas and hoped that they could install more in other areas of the City. She advised that Florida Department of Transport (FDOT) was doing a lighting improvement project in five cities and discussed the same.

COMMISSIONER ARSERIO thanked the residents and colleagues for putting their faith and trust in him and referenced his one-year anniversary of being elected a City Commissioner. He echoed Commissioner Simone's comments pertaining to the City's recent events. He thanked the Highway Patrol and Margate Police Department for coordinating the Arrive Alive campaign.

COMMISSIONER SCHWARTZ congratulated everyone who participated in the Trunk or Treat event. She spoke about the new playground at Firefighters' Park and referenced the new zipline. She highlighted Broward County's Read for the Record event at local schools.

VICE MAYOR RUZZANO highlighted the Veterans' Day ceremony and referenced a fully functional new bathroom. He congratulated Fire Chief Lorenzo's daughter for competing in a track event in Tallahassee. He discussed a recent meeting on McDivot's Golf Course and questioned whether they could change the zoning to recreational.

Discussion ensued on changing the zoning.

CITY MANAGER CURTIS said that he would research and let the City Commission know.

DEVELOPMENT SERVICES DIRECTOR, ROBERT J. MASSARELLI explained that in the current zoning district for that area, golf courses were eliminated two years ago. He asked if it was the CONSENSUS of the Board and the City Manager, they could start drafting up an Ordinance pertaining to that.

Discussion ensued.

CITY ATTORNEY JANETTE M. SMITH explained that she would look at all aspects and revert back to the City Commission in a month's time.

Discussion ensued.

VICE MAYOR RUZZANO discussed a resident who was looking to do a Bocce ball court at one of the parks in the City. He said it was a great job that Lennar backed out.

CONSENSUS was given by the City Commission directing staff to research a zoning change for the McDivot's Golf Course and to research the installation of a Bocce ball

court.

MAYOR CAGGIANO echoed comments made pertaining to Trunk or Treat and Fall Festival events and said hats off to City staff who participated. He said that he handed out over 1,000 of the City's recycling flyers at the Trunk or Treat event. He discussed a recent event at the North West Focal Point Senior Center (NWFPSC) pertaining to different programs that they were doing for senior citizens and said that Congressman Ted Deutch was in attendance. He explained that after that event, he received a call from the new Director of Aging and Disability Resource Center that asked him to be part of their brand new dementia program which he accepted.

Discussion ensued.

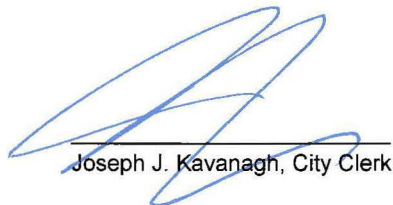
CONSENSUS was given by the City Commission for staff to bring back an Ordinance with recommendations addressing inspections, landscaping, lighting and a variety of other elements.
