2) PUBLIC DISCUSSION

CHARLIE ARTNER, 6631 NW 22ND COURT requested a future Agenda Item on a
moratorium on green spaces such as the golf course.

COMMISSIONER ANTONIO V. ARSERIO said that the City had addressed this in their
Strategic Plan. He also advised that the Planning and Zoning (P&Z) Board recommended
the Commission to change the text amendment to add golf courses back in. He believed
that putting in a moratorium would be a detriment to the community and discussed
declining profit values due to the abandoned golf course.

Discussion ensued on the Strategic Plan, building a hotel on one of the golf courses,
putting in a moratorium on green spaces and developing and revitalizing shopping
centers.

JULI VANDERMEULEN, 2913 NW 68 LN. questioned who was going to pay for the
remediation and also referenced a previous City Commission turning down the offer of the
Fern Forest Nature Center. She continued to discuss Margate's green space and the
purchase of land.

COMMISSIONER ARSERIO responded to Mrs. Vandermeulen's comments.

Discussion ensued.

CHRISTOPHER A. SNYDER, 2741 SW 81ST WAY, DAVIE discussed 13th Floor Homes and referenced transfer of rights to another developer. He thanked and credited the Commission for listening to the residents on this matter. He indicated that they would need to measure the owner's options as and when they arose. He thanked Mr. Artnr for his efforts.

MARILYN A. KNEELAND, 7955 NW 5TH CT spoke on behalf of the Keep Margate Green Committee pertaining to the Executive Golf Course. She thanked the City Commission and asked for an update on Alex Pappas from Lee & Associates South Florida.

Discussion ensued.

GRANT R. O'DONNELL, 3011 HOLIDAY SPRINGS BOULEVARD questioned that if there was a referendum, whether the City could re-open a golf course after it had closed for a six-month period. He thanked the City for their hard work and also for work that had been performed on the park and said that it looked great.

COMMISSIONER ARSERIO responded to Mr. O'Donnell's comments.

ELSA J. SANCHEZ, 6930 NW 15TH STREET requested an update on the Firehouse on Rock Island and referenced a fire fee.

MAYOR TOMMY RUZZANO provided an update and advised that the architect had almost completed the drawings and the bid documents.

Discussion ensued.

RICH ALIANIELLO, 7631 NW 23RD STREET discussed water pressure.

CITY MANAGER CALE D. CURTIS said that he would have staff pick up where Mr. Griffin left off concerning his water pressure.

JULIE JONES, 7871 NW 1ST STREET referenced social media comments and discussed derogatory posts. She thanked Commissioner Arserio for allowing her to work on his election.

MAYOR RUZZANO discussed social media comments.

Discussion ensued.

DARA KUSTLER, 554 NW 76TH TERRACE discussed the golf courses and said that the City Commission was all doing a wonderful job. She also discussed and referenced fees being proposed for the fire station and requested a citizen's committee.

LAUREN BERACHA, PARADISE GARDENS III discussed a homeless person found at a shopping center at Winfield Boulevard and 441.

VICE MAYOR ARLENE R. SCHWARTZ highlighted the Police Department's Homeless Task Force. She spoke further on the homelessness in Margate.

3) COMMISSION COMMENTS

COMMISSIONER ANTHONY N. CAGGIANO congratulated Mr. Hopper for his work for the City and wished him a tremendous retirement in his new location. He spoke about the importance of the 2020 Census.

COMMISSIONER JOANNE SIMONE advised that residents should be mindful of personal hygiene pertaining to the Coronavirus disease (COVID-19).

COMMISSIONER ANTONIO V. ARSERIO discussed Mr. Krell's behavior at this evening's City Commission meeting. He addressed misinformation on social media pertaining to the golf course. He discussed an email and correspondence sent to Michael Nunziata, the Principal of 13th Floor Homes. He gave kudos to the City Clerk for the online portal for the public records request. He also said that the City was looking at software where residents could look at capital projects.

CITY CLERK JOSEPH J. KAVANAGH explained that they had extra money budgeted in the City Clerk's account for various software packages.

COMMISSIONER ARSERIO continued his discussion of misinformation pertaining to the golf course and questioned if they could have a section inserted on the City's website for regular updates.

MAYOR RUZZANO indicated that if the Board was willing to do that, they could look into providing an update on the golf course.

Discussion ensued on initiating software and updating residents pertaining to the golf course.

COMMISSIONER ARSERIO said that he wanted to start an Information Task Force.

VICE MAYOR SCHWARTZ highlighted the problems of receiving Margate Matters one month too late due to the billing cycle and referenced communication. She discussed the proposed new Fire Station and compared it to surrounding cities. She advised on the upcoming Daylight Savings and thanked the members of the Fire Department for attending the meeting.

MAYOR RUZZANO wished his in-laws a Happy 50th Wedding Anniversary. He said that the first turf project at the soccer field at Southeast Park looked incredible. He highlighted the upcoming State of the City meeting on March 25th. He discussed a Facebook post from a Margate resident pertaining to green space and said that he wished that the City could do a twice per year tree giveaway.

Discussion ensued on trees.

COMMISSIONER ARSERIO discussed the City's Strategic Planning procedure.

Discussion ensued on residential priorities for the City's Strategic Planning and the City's parks.

MAYOR RUZZANO highlighted that the Margate United Soccer League was taking reservations for the forthcoming season.

VICE MAYOR SCHWARTZ highlighted the St Patrick's Day Parade at Oriole Gardens III.

4) CITY MANAGER'S REPORT

CITY MANAGER CURTIS advised that since the last City Commission meeting, Waste Management had subsequently reversed their decision to eliminate paper from their recycling program. He explained that City staff met with Broward County Highway & Bridge Maintenance Division pertaining to the intersection at Rock Island and Royal Palm Boulevard where they had plans to improve that area which was currently going through design. He said that the Police Department were selected as first place winners for a photo contest with Graphic Designs International. He said that under the resident's tab, a link had been added to the City's website on the Coronavirus disease (COVID-19).

A motion was made by Vice Mayor Schwartz, seconded by Commissioner Simone, that this Ordinance, First Reading, should be discussed.

COMMISSIONER SIMONE said that she had concerns with two of the items and would like to discuss them before voting. She was against spending \$50,000 on the City's 65th Anniversary and also said that she had an issue with the advertisement fee of \$25,000 for the 2020 Census. She explained that she would prefer to reduce the Census down to \$1,000.

Discussion ensued.

An amendment was made by Commissioner Simone, seconded by Mayor Ruzzano, to add AT&T U-Verse streaming services in the amount of \$10,000.

Discussion ensued.

MR. ALIANIELLO spoke on the streaming service and camera.

MS. JONES said that if they were going to use AT&T, then they should also include Dish Network.

Discussion ensued.

MS. KUSTLER questioned the date of Margate's 65th anniversary. She said that it was unfair that they only had one service provider pertaining to the streaming service.

Discussion ensued.

The amendment carried by the following vote:

Yes: 5 - Commissioner Caggiano, Commissioner Simone, Commissioner Arserio, Vice Mayor Schwartz and Mayor Ruzzano

Discussion ensued regarding the Community Redevelopment Agency Board (CRA) picking up some of the costs of the City of Margate 65th Anniversary event and to have it discussed at the March 11th, 2020 CRA Board meeting.

MS. KUSTLER said that goals could be measured but they needed to do the job. She said that she agreed with Commissioner Simone regarding the \$50,000 for the 65th Anniversary party. She also disagreed with the \$25,000 for the 2020 Census.

Discussion ensued.

MR. ALIANIELLO indicated that he did not see any problem with the monetary amount for the 65th Anniversary party.

MS. SANCHEZ said that she agreed with Commissioner Simone that \$50,000 was too much money. She also questioned who the CRA was.

MS. BERACHA said that she agreed with Commissioner Simone and discussed sponsorship.

Discussion ensued.

VALERIE PERRY 6812 DOGWOOD LANE suggested that at the July 4th party, they should commemorate the City's anniversary by encouraging the pyrotechnics company to do a big "65th Happy Birthday Margate" which would cost far less than \$50,000.

Discussion ensued.

The original motion as amended carried by the following vote:



[Appendix A – Zoning – Section 3.3] Any representation made before any City Board, any Administrative Board, or the City Commission in the application for a variance, special exception, conditional use or request for any other permit shall be deemed a condition of the granting of the permit. Should any representation be false or should said representation not be continued as represented, same shall be deemed a violation of the permit and a violation of this section.
