Item 1D was heard before 1A.

MAYOR TOMMY RUZZANO said that they do a great job and loved the work that North West Focal Point Senior Center (NWFPSC) Project Director Karin Diaz and her team did.

NORTH WEST FOCAL POINT SENIOR CENTER (NWFPSC) PROJECT DIRECTOR KARIN DIAZ discussed the proclamation and thanked the City Commission for recognizing their older adults.

CITY MANAGER CALE D. CURTIS introduced this Item and explained that it would effectively change the way they sourced their City wide vehicles. He introduced Kathryn Williams and a Christina Anthony from the chat room.

ENTERPRISE VEHICLE LEASING PROGRAM, ACCOUNT EXECUTIVE, CHRISTINA ANTHONY said that both she and her colleague, Kathryn Williams, would be going over the vehicle leasing program for the City. She did a PowerPoint presentation and gave an overview of Enterprise Holdings. She said that they had over 1,400 government entities across the US and that they were managing their fleets and highlighted local success stories. She identified a ten-year implementation plan that was going to help save the City over \$2,000,000 and said that they would continue to work with Margate on developing the same. She provided illustrations of a simple way to consult entities in terms of their vehicles and fleet and referenced a F150 pick-up truck.

ENTERPRISE VEHICLE LEASING PROGRAM, FLEET ANALYST, KATHRYN WILLIAMS, discussed financing, mileage and replacing vehicles and referenced the City's capital fleet budget of \$824,000.

Discussion ensued in a question and answer session.

CITY MANAGER CURTIS said he would formalize the program and bring it back for consideration by the City Commission.

### 2) PUBLIC DISCUSSION

CITY CLERK JOSEPH J. KAVANAGH read a phone message from Margate resident, Julie Jones, explaining that she had problems contacting members of staff and that they would not return voicemail messages.

MAYOR RUZZANO said that he would have the City Manager look into it but indicated that all staff should be accessible.

JULI VAN DER MEULEN, 2913 NW 68 LN. referenced the Coronavirus disease (COVID-19) and requested pop-up drive-in movie theatres during the Summer period.

MAYOR RUZZANO loved the idea but suggested that the Community Redevelopment Agency (CRA) would be a better group to discuss this issue.

CITY MANAGER CALE D. CURTIS was happy to hear the concept and said that he would work with Parks and Recreation Director Jones on different options.

Discussion ensued on food trucks pertaining to drive-in theatres.

CITY CLERK JOSEPH J. KAVANAGH explained the protocol for submitting a comment or discussion item.

## 3) COMMISSION COMMENTS

COMMISSIONER ANTHONY N. CAGGIANO requested everyone to adhere to the rules during the pandemic by observing social distancing measures and wearing a mask. He thanked Margate's first responders and everyone else who was involved in honoring the birthday celebrations for the children and said that this was also highlighted on The Forum's front cover.

COMMISSIONER JOANNE C. SIMONE referenced the drive-in movies and explained that she had received other requests from residents on the same issue. She also informed that she had requested City Manager Curtis to review this during an Agenda review. She congratulated the listed employees for their years of service. She referenced financial challenges and the North West Focal Point Senior Center (NWFPSC) and asked the City Commission for CONSENSUS to freeze all donation spending during the COVID-19 crises. Discussion ensued.

CONSENSUS was not reached.

COMMISSIONER ANTONIO V. ARSERIO expressed his excitement on seeing the dog park open and that he had received positive feedback. He also highlighted some constructive criticism on the requirement for shading in the park and suggested that they could plant some fast growing trees and referenced Firefighter's Park. He also suggested that the City staff could do the landscaping to save money. He thanked the first responders.

Discussion ensued on the dog park pertaining to fencing, planting a hedge, dogs digging under hedges, banners and problems with iguanas.

GRANT R. O'DONNELL, 3011 HOLIDAY SPRINGS BOULEVARD, #205 discussed voluntary work by Home Depot staff pertaining to helping cities with shrubs, cleaning and making places look nice. He suggested that if the City was to approach one of the Home Depot Managers, they often donated items and said that he could make a call to the District Manager to see if there was the possibility of an opportunity.

Discussion ensued on donations from Home Depot.

VICE MAYOR SCHWARTZ showed a picture of a child in a police truck in The Forum. She agreed that there was not enough shade at the dog park and would be in favor if residents wanted to do landscaping at that location. She thought it was a great idea for the movies in the park and loved for the location to be on the east side of State Road 7/441. She referenced Ms. Jones experiencing problems contacting City staff and said that she was not alone and highlighted problems with voicemail mailboxes being full. She requested City Manager Curtis to remind staff to listen to their messages. She informed that there was a meal distribution every Tuesday at Margate Middle School. She said Happy Father's Day for Sunday.

MAYOR RUZZANO discussed the dog park's great soft opening and spoke about a future dog sculpture. He suggested engraving some spare bricks in the memory of dogs or family members which could be charged at \$50 per brick which would raise revenue for the City. He discussed yesterday's Broward County Commission's long meeting which would be resumed tomorrow and referenced cities putting a referendum on the ballot for November's election. He explained that Item 81 pertained to whether or not the County would be able to utilize city parks as and when needed and highlighted the COVID-19's food outreach program as example. He also explained that for Item 82, this would pertain for any County owned property in the respective cities and whether they could do whatever they wanted on it and referenced the possibility of home rule. He said that no one at the meeting was in favor of those two Items and that the Broward County Manager discussed the cellphone tower in Hollywood which the County wanted but the City did not want. He said that it was strange that the County wanted to do things different to that of the cities. He indicated that at the continuation of the Broward County meeting, they would also discuss the \$340,000,000 Coronavirus Aid, Relief, and Economic Security (CARES) Act fund. He referenced that respective City Managers have put together a bill of approximately over \$100,000,000 of what the cities required.

CITY MANAGER CURTIS informed that Broward County was putting in a new bus route on Rock Island Road between Turtle Creek on Sample Road down to Broward Central terminal. Discussion ensued on the installation of bus stops by Broward County along Rock Island Road.

CITY ATTORNEY JANETTE M. SMITH said she would work with City Manager Curtis to review the agreement and that she would also get back to the City Commissioners with more information on the project.

MAYOR RUZZANO asked for the City Manager to arrange a tour for the City Commission to review the condition of the canals.

Discussion ensued on the C-14 canal.

CONSENSUS was given by the City Commission for the City Manager to arrange the tour.

CITY MANAGER CURTIS reminded the City Commission to contact the Broward County Commissioners to express their thoughts on their Agenda Items of 81, 82 and 100 which they would be addressing at the continuation of the County's meeting tomorrow night. He discussed Item 100 which pertained to the CARES Act funding.

Discussion ensued on Broward County Agenda Items and a recent School Board meeting.
