### PLEDGE OF ALLEGIANCE

#### 1) PRESENTATION(S)

A. [ID 2020-279](#) UPDATE BY THE BROWARD METROPOLITAN PLANNING ORGANIZATION.

THE METROPOLITAN PLANNING ORGANIZATION (MPO) EXECUTIVE DIRECTOR GREG STEWART introduced his colleague, Peter Gees.

MPO STRATEGIC PLANNING MANAGER PETER GIES explained his position within the organization and said that there were 27 MPOs in the State of Florida. He said that he

would provide them with an update on projects that were going to be funded and that were effective in and around the Margate area.

Discussion ensued with a question and answer session with the City Commission.

COMMISSIONER ANTONIO V. ARSERIO thanked the MPO for their presentation. He identified that landscaping was very important and would like that to be implemented if they were going to add bike lanes and walkways, especially on Southgate Boulevard.

CITY MANAGER CALE CURTIS advised that the Public Works Director Collins had been working on the MPO projects and that he would report back as to what projects they were considering.

Discussion ensued.

VICE MAYOR ARLENE R. SCHWARTZ asked about the Southgate Boulevard project. She said that she was a great proponent of a bicycle lane going down on Rock Island Road on the east side of the street. She identified that there was a massive need for a westbound turn lane at Rock Island and Royal Palm Boulevard.

Discussion ensued.

COMMISSIONER ANTHONY N. CAGGIANO thanked the MPO for their presentation and indicated that both Commissioner Arserio and Vice Mayor Schwartz highlighted the projects that he wanted to discuss.

Discussion ensued.

COMMISSIONER JOANNE SIMONE referenced a project on Rock Island Road from Sample Road that the City Commission had turned down and asked whether this could be brought back.

Discussion ensued on the project that was turned down.

RICHARD ZUCCHINI, 380 LAKEWOOD CIRCLE E, #B said that he was also on the MPO Civilian Board and discussed his experience of reviewing approximately 460 projects.

MAYOR TOMMY RUZZANO explained that he was not for bicycles and cars sharing the same road.

Discussion ensued including bicycle lanes and wider sidewalks.

ELSA J. SANCHEZ, 6930 NW 15TH STREET thanked the City for the masks that were given to the residents of Paradise Gardens III, thanked Officer Phanor for help with a residential incident. She referenced a tax bill and requested an update on the Fire fees.

MAYOR RUZZANO responded to the question raised on the fire fees.

Discussion ensued.

CITY MANAGER CURTIS referenced the Millage rate that was raised for communications and dispatches and said that it would be used for whatever system the City decided to go to.

LAUREN BERACHA, 6950 NW 14TH PLACE discussed the proposed tax bill and referenced the fire fees.

CITY MANAGER CURTIS responded to Mrs. Beracha's query.

Discussion ensued on the Fire assessment.

## 3) COMMISSION COMMENTS

COMMISSIONER CAGGIANO requested people to stay safe.

COMMISSIONER JOANNE SIMONE congratulated the employees for their dedicated years of service. She discussed those that may be affected by Hurricane Laura in the Southern States. She said that Florida Power & Light Company (FPL) were working on lights and that she received requests from residents for lights to be installed on the cul-de-sacs off Margate Boulevard.

CITY MANAGER CURTIS informed that he would follow up this request with his representative at FPL.

COMMISSIONER SIMONE asked people to continue to be safe. She highlighted the Mask Giveaway event on Saturday.

COMMISSIONER ANTONIO V. ARSERIO referenced the hurricane and wished everyone in the Southern States the best. He also discussed hurricane preparation for Florida and referenced a request for a sand bagging machine.

CITY MANAGER CURTIS indicated that the City was looking at different options for the sand bagging machines.

COMMISSIONER ARSERIO discussed FPL's light installation and referenced overgrown trees obstructing the light.

VICE MAYOR ARLENE R. SCHWARTZ highlighted Culver's recent soft opening. She referenced the Employee Anniversaries and suggested that at a later date, there would be an opportunity to celebrate with these employees. She thanked Parks and Recreation for assisting in distributing masks across the community. She added her prayers to those affected by the hurricane.

MAYOR RUZZANO discussed the FPL light project. He indicated that the City would be hosting a Tree giveaway in the near future. He asked the City Commission if they had any ideas on this year's Trunk or Treat event during the Coronavirus disease (COVID-19). He discussed the Mask Giveaway to those in the community and highlighted its forthcoming event for Saturday. He said that the Broward County Commission voted unanimously to approve The Coronavirus Aid, Relief, and Economic Security (CARES) Act funding with the cities. He hoped that one day, the City could celebrate Margate's 65th birthday.

#### 4) CITY MANAGER'S REPORT

CITY MANAGER CURTIS highlighted the requirements for Saturday's Mask distribution. He indicated that the City were working on different initiatives for this year's popular Trunk or Treat and said that a drive-in movie type of event was one of the considerations.

She advised that if this Item was approved, it would be transmitted to the State and the next steps would be for it go to the District Development Officer (DDO) for review and then The Mellgren Planning Group and the City would have to address any revisions. She explained that thereafter, it would go to the City for adoption on November 4th. She also advised that in addition to the County Commission voting for the CARES Act, they also voted to table indefinitely, the mandatory requirement that they were considering for inclusionary housing of affordable or workforce and low income housing.



[Appendix A – Zoning – Section 3.3] Any representation made before any City Board, any Administrative Board, or the City Commission in the application for a variance, special exception, conditional use or request for any other permit shall be deemed a condition of the granting of the permit. Should any representation be false or should said representation not be continued as represented, same shall be deemed a violation of the permit and a violation of this section.

- Pursuant to Governor DeSantis' Executive Orders 20-51 and 20-52, in which the Governor declared a public health emergency and a state of emergency, there is a recommendation to limit public gatherings.
- On March 20, 2020, Governor DeSantis issued Executive Order 20-69, suspending the quorum requirements for public meetings held by a local government body, and the requirement that a local government body must meet at a specific public place.
- On August 7, 2020, Governor DeSantis issued Executive Order 20-193, extending Executive Order 20-69 regarding local government public meetings until 12:01 a.m. on October 1, 2020.
- Consistent with the authority contained in the Governor's Executive Orders, and in order to ensure the health, safety, and welfare of the City of Margate's clients and employees, the City of Margate finds that it is in the best interest of the City of Margate to hold this virtual public meeting.


