## 2) PUBLIC DISCUSSION

CITY CLERK KAVANAGH explained the protocol for submitting a Public Discussion. He read a letter from Mitchell Pellecchia of 6890 NW 9th Street pertaining to civil rights of Margate residents in the wake of Governor DeSantis' Riot Bill that was signed this week. He also requested the City Commission to rethink two Consent Agenda Items pertaining to disposition of law enforcement trust fund dollars.

MAYOR SCHWARTZ stated that Chief of Police Shaw was not a Charter Officer and he reported to the City Manager.

JULIE JONES, 7871 NW 1ST STREET read a statement pertaining to law enforcement officers and thanked them for serving and protecting the public.

## 3) COMMISSION COMMENTS

COMMISSIONER ANTHONY N. CAGGIANO said that Commissioner Ruzzano's family was in their thoughts. He expressed good wishes to those in the community celebrating Ramadan. He highlighted the City's Tree Giveaway event.

COMMISSIONER JOANNE SIMONE congratulated staff listed on the Employee Years of Service and also Assistant City Clerk Jennifer M. Johnson for being appointed to the International Institute of Municipal Clerks (IIMC) 2021/2022 Education and Professional Development Committee. She thanked Public Works for the plexiglass dividers. She apologized that she may not be able to attend Southgate Park's grand opening this weekend due to a prior commitment.

MAYOR SCHWARTZ discussed Southgate Park's grand opening. She highlighted the type of trees available at the City's Tree Giveaway and was advised that there were 350 trees excluding anything that was donated. She informed that Margate's Walmart would be giving Coronavirus disease 2019 (COVID-19) Moderna vaccinations. She sent heartfelt wishes to the Ruzzano family and also Vice Mayor Arserio's family. She forewarned that she may ask for some Agenda Items to be pulled from the Agenda as she felt it was inappropriate due to the absence of two City Commissioners.

Discussion ensued on the Tree Giveaway.

CITY MANAGER CURTIS highlighted the ribbon-cutting event at Southgate Park for this Saturday. He referenced that Broward County had lifted restrictions on pools and

reminded the public that Calypso Cove reopened recently for use at the weekends. He said that they were excited about their new magazine, Our Margate.

COMMISSIONER CAGGIANO highlighted two upcoming events of Drug Enforcement Administration (DEA) National Prescription Drug Take Back Day event and the Household Hazardous Waste and Electronics Disposal.

MAYOR SCHWARTZ said there was a new sign being erected at David Park.

[Appendix A – Zoning – Section 3.3] Any representation made before any City Board, any Administrative Board, or the City Commission in the application for a variance, special exception, conditional use or request for any other permit shall be deemed a condition of the granting of the permit. Should any representation be false or should said representation not be continued as represented, same shall be deemed a violation of the permit and a violation of this section.
