2) PUBLIC DISCUSSION

TRACY VAN WINKLE, 1020 SW 61ST AVENUE, congratulated Margate Middle School Girls' Soccer team on getting to the playoffs. She discussed social media platforms and referenced blue checks on Facebook and fake news. She discussed the City's full time hours, square mileage in Margate and referenced perks and a \$300 car allowance. She complained about the trash in the City and spoke about residents seats.

RICH ALIANIELLO, 7631 NW 23RD STREET, spoke about the 2% pay raise that was discussed at the last City Commission meeting. He asked people not to throw trash outside their car. He suggested that they should have stayed with Waste Management when their contract expired next February. He said that the City Commission was doing a good job and they earned everything they did.

VICE MAYOR ANTONIO V. ARSERIO responded to Mr. Alianiello's comments on Waste Management.

MARIE H. GRIFFIN, 2902 NW 62ND AVENUE, discussed an issue pertaining to a shed being placed on her property since April.

MAYOR ARLENE R. SCHWARTZ responded to Ms. Griffin's comments.

Discussion ensued with the City Commission.

LAUREN BERACHA, 6950 NW 14TH PLACE, spoke about accidents caused by speeding on Margate Boulevard and surrounding roads.

3) COMMISSION COMMENTS

COMMISSIONER CAGGIANO said everyone had a great time at last Saturday's Sounds

at Sundown. He highlighted the upcoming recycled paint and Fall Festival events.

COMMISSIONER JOANNE SIMONE questioned if there was an update on the faulty electronic speed sign on Rock Island Road.

CITY MANAGER CALE CURTIS advised that he would follow this up with Acting Chief of Police Galaska on getting that sign reprogrammed.

COMMISSIONER JOANNE SIMONE explained that new information about Acting Chief of Police Galaska had surfaced today and she read a statement. She asked for a reconsideration of the appointment of Acting Chief of Police Galaska and the City's Internal Affairs (IA).

Discussion ensued.

CITY MANAGER CALE CURTIS explained that he had received an email with additional complaints regarding the Police Department. He advised that he would be working with the Interim City Attorney's Office to procure an independent 3rd party to investigate the complaints and the entire Police Department.

INTERIM CITY ATTORNEY DAVID N. TOLCES explained the legalities pertaining to making a motion.

A motion was made by Commissioner Simone, to reconsider the appointment of Joseph Galaska as Acting Chief of Police. The motion died for lack of a second.

A motion was made by Commissioner Simone, to reconsider to not have Margate Police IA conduct the investigation into the complaints against former Chief of Police, Jon Shaw. The motion died for lack of a second.

Discussion ensued.

COMMISSIONER TOMMY RUZZANO said he talked with Broward County School Board Representative, Lori Alhadeff and that they were looking to redistrict and give Margate a third School Board member with no schools.

Discussion ensued.

COMMISSIONER RUZZANO said that the Sounds at Sundown was awesome and that Parks and Recreation did a great job. He highlighted the upcoming Fall Festival event and confirmed that Calypso Cove was now closed until next season. He said that they started baseball back last night.

VICE MAYOR ANTONIO V. ARSERIO highlighted the opening of a Brazilian Steakhouse in Margate.

MAYOR ARLENE R. SCHWARTZ highlighted the attendance at the last Sounds at Sundown and advised on future City events. She referenced a newspaper article and said that the City of Tamarac was imposing the collection of a non-ad valorem assessment for nuisance abatement and indicated that Margate should introduce this system. She continued to explain the process of the non-ad valorem.

INTERIM CITY ATTORNEY TOLCES advised that the non-ad valorem assessment for a nuisance abatement was specifically related to activities actually taken by the City to remedy nuisances on properties and therefore, the Code Enforcement were separate.

Discussion ensued with the possibility of adding this Item on a future Agenda.

COMMISSIONER CAGGIANO wanted to thank the Public Information Office for seeing Margate being celebrated and referenced that the City was on the front page of The Forum.

4) CITY MANAGER'S REPORT

CITY MANAGER CURTIS advised that the design of the Winfield Boulevard Bridge was almost 90 percent complete but construction funding within the surtax funds had not been obligated in the five year plan. He said that they would continue to work with them to see if they could re-prioritize any funds for almost a complete design but they were reliant upon Broward County obligating funding for their projects. He was informed that the City's Police Department had been working with Coral Springs' Police Department pertaining to the Coral Bay traffic issues.

VICE MAYOR ARSERIO referenced proper community outreach and to inform other appropriate parties what action had been taken.

CITY MANAGER CURTIS highlighted that the Police Department was hosting their annual Trunk or Treat event.

COMMISSIONER RUZZANO received an inquiry from a Community Redevelopment Agency (CRA) business asking if they could be incorporated with the City's Trunk or Treat event and continue handing out candy when Margate completed their own.

Discussion ensued.

> CITY CLERK JOSEPH J. KAVANAGH explained that a full audit of all the Minutes for the City Commission was conducted and that there was approximately 10 meetings from the 1990s that the City Clerk's office found no record of. He advised that as they were transitioning to an electronic records management software called Laserfiche, it was his obligation to create minutes for these meetings. He consulted with their Interim City Attorney to ensure that they were following the best practices.

Applicant shall make good faith efforts to:

*Limit trucks traveling north bound on Banks Road, north of Northwest 24th Street, including placing signage on their property providing for no left turns onto Banks Road from Northwest 24th Street.

*Petition Broward County for signage on the center island prohibiting u-turns.

*Work with the City for additional signage and implementation of traffic control measures to minimize large trucks driving on Banks Road, subject to traffic circulation plan as part of the site plan review.

COMMISSIONER RUZZANO requested that the City consider a sign with penalties that say "no trucks allowed on Banks Road."
