RICHARD ZUCCHINI, 380 LAKEWOOD CIRCLE E, read a statement supporting incoming Mayor Arserio and provided some suggestions for signature initiatives to start under his administration including a reference to Palm Lakes Golf Course.

MAYOR SCHWARTZ confirmed that Palm Lakes Golf Course had been recently sold.

Discussion ensued on Palm Lakes Golf Course.

SYDNEY KING, 2111 NW 76TH AVENUE, congratulated the outgoing and incoming Mayor and Vice Mayor and applauded their efforts. He listed organizations that he was involved in and said that they were at the City's disposal and wished everyone to be healthy.

4) PUBLIC DISCUSSION

INTERN WITH FLORIDA STATE REPRESENTATIVE CHRISTINE HUNSCHOFSKY'S OFFICE, ANTHONY AVELLO, PARKLAND RESIDENT, read a statement in the absence of Ms. Hunschofsky, offering their help to the City and residents.

VICE MAYOR ANTONIO V. ARSERIO thanked and complimented Mr. Avello.

FOUNDER AND DIRECTOR OF THE DANIA BEACH VERVET PROJECT, DEBORAH WILLIAMS, discussed the Banana Derby.

DONNA L. FELLOWS, 6108 NW 9TH COURT, questioned the security fence for the Broward County Fair. She thanked Mayor Schwartz for her service and wished good luck to the respective incoming Mayor and Vice Mayor.

JONATHAN KRALJIC, 7357 FLORES WAY, referenced Broward County and discussed the removal of palm trees.

MAYOR SCHWARTZ responded to Mr. Kraljic's comments.

MR. ZUCCHINI responded to Ms. Williams' comments.

Discussion ensued.

MR. ALIANIELLO congratulated incoming Vice Mayor Caggiano and Mayor Schwartz. He also discussed Commissioner Simone.

Discussion ensued.

ANA CAMPOS, 3032 E. COMMERCIAL BLVD, FT. LAUDERDALE, urged the City Commission to possibly intervene and cancel the Banana Derby at the Broward County Fair

5) COMMISSION COMMENTS

COMMISSIONER CAGGIANO thanked Mayor Schwartz for all the work she put in.

COMMISSIONER TOMMY RUZZANO congratulated Mayor Schwartz and said that he enjoyed working with the rest of the City Commission. He said that he spoke to the former Parkland Mayor Udine who was now the Broward County Mayor. He handed out old literature on the Broward County Fair pertaining to a talent contest and asked if the City Commission wanted to move forward with something similar. He attended the premises of the Broward County Fair today and discussed the Banana Derby and said that the owner of the race had a permit for it.

MAYOR SCHWARTZ advised that the Banana Derby owner had a United States Department of Agriculture (USDA) permit.

COMMISSIONER RUZZANO continued to talk about the Banana Derby and referenced the alleged abuse to animals. He asked whether they should distribute gift certificates similar to the Halloween Giveaway and also questioned what was the appropriate action needed. He also asked why no action was required when the City distributed approximately \$10,000 worth of Publix gift cards to their employees.

CITY MANAGER CALE CURTIS explained that \$2,400 would be within his spending authority but for a concept like this, it would be appropriate for the City Commission to consider it and provide feedback for him to participate or provide a price for a contest of this nature.

Discussion ensued.

COMMISSIONER RUZZANO read a handout pertaining to a previous event on the Broward County Fair event. He discussed whether the City was interested in moving forward with a Talent Show Contest at the Broward County Fair.

Discussion ensued.

CONSENSUS was given by the City Commission to move forward with the Talent Show Contest.

COMMISSIONER RUZZANO requested another tree giveaway in the near future. He referenced the green t-shirt attendees at the meeting and said that he had not heard anything.

VICE MAYOR ANTONIO V. ARSERIO referenced a tax bill being received in the mail and said that Margate did not raise their taxes and that their overall rate went down. He explained why the tax bill may have increased in the State and also referenced the Fire Assessment fee.

MAYOR SCHWARTZ referenced the last City Commission meeting pertaining to fences being discussed and read a statement on the 1990 construction of fences, walls and/or hedges. She congratulated the incoming Mayor and Vice Mayor.

Discussion ensued on the uniform style of fences.

6) CITY MANAGER'S REPORT

CITY MANAGER CURTIS thanked Mayor Schwartz and Vice Mayor Arserio for their service and congratulated the incoming Mayor Arserio and Vice Mayor Caggiano. He advised that the Broward County Fair committed to provide 75 passes for Students and Athletes of the Month and said that they had approximately 40 passes remaining. He asked for CONSENSUS to distribute the 40 remaining Broward County Fair passes to Margate schools, with each school receiving 10 passes.

CONSENSUS was given by the City Commission.

CITY MANAGER CURTIS asked for CONSENSUS to allow the Broward County Fair vendor to utilize the Margate Show Mobile stage by waiving the hourly rate but still charge the labor rate.

Discussion ensued.

CONSENSUS was given by the City Commission to waive the hourly rate and charge the labor rate for the use of the Margate Show Mobile stage.

CITY MANAGER CURTIS also reiterated Commissioner Ruzzano's request for the Talent Show Contest.

Discussion ensued on the use of the Margate Show Mobile stage.

INTERIM CITY ATTORNEY TOLCES congratulated the Mayor and Vice Mayor elect and said that he looked forward to working with them. He thanked the current Mayor and Vice Mayor for being able to work with them and wished everyone a Happy Thanksgiving. He addressed the Sunshine law on what items could be discussed at City Commission meetings.

COMMISSIONER RUZZANO questioned the cost of lawyer fees for restraining orders on behalf of the City Commission.

INTERIM CITY ATTORNEY TOLCES provided some brief guidance and explained that he would like to research this further but thought that any expenditure would have to be authorized by the City Commission.

Discussion ensued.

CITY CLERK JOSEPH J. KAVANAGH said that it had been a pleasure working with both the outgoing Mayor and Vice Mayor in the past year. He looked forward to working with both incoming Mayor Arserio and Vice Mayor Caggiano.

10) DISCUSSION AND POSSIBLE ACTION

Mayor Schwartz asked for Item 10B to be read before 10A.

B. ID 2021-477 DISCUSSION AND POSSIBLE ACTION: MERIT INCREASE FOR CITY CLERK.

Item 10B was heard before item 10A.

MAYOR SCHWARTZ explained that she put this Item on as it became apparent that certain staff were not part of the City's Step plan. She indicated that the City Clerk's office worked stellar during the pandemic. She suggested that they increase the City

Clerk's salary by 10 percent.

Discussion ensued which included whether City Manager Curtis should also receive an increase.

A motion was made by Commissioner Ruzzano to provide a 10% merit increase for City Clerk Kavanagh and City Manager Curtis.

The motion failed for lack of a second.

A motion was made by Commissioner Caggiano, seconded by Mayor Schwartz, to provide a 10% merit increase for City Clerk Kavanagh.

MR. ALIANIELLO spoke on this Item.

MS. SANCHEZ agreed 100% with Mayor Schwartz on all her points.

JULI VAN DER MEULEN, 2913 NW 68 LN. suggested that the Step program should go and raises should be merit based. She provided her opinion on both the City Clerk and City Manager's respective salaries.

JULIE JONES, 7871 NW 1ST STREET explained that as a resident and board member, she was lucky to work with City Clerk Kavanagh and said that he deserved the raise.

MRS. BERACHA thanked Mayor Schwartz for initiating this and said that she agreed with all of the speakers that have discussed this Item. She indicated that City Clerk Kavanagh deserved the raise.

COMMISSIONER RUZZANO provided clarification on his earlier discussion on this Item.

The motion carried by the following vote:

CITY CLERK KAVANAGH thanked the City Commission for their support.

Discussion ensued.

A. ID 2021-475 DISCUSSION AND POSSIBLE ACTION: FLORIDA RETIREMENT SYSTEM - ELECTED STATE AND COUNTY OFFICERS.

Item 10A was heard after item 10B.

CITY MANAGER CURTIS provided a 17 page memorandum describing an issue that related to retired members of the City Commission. He explained that under the Florida Retirement System (FRS), they were not achieving the same benefit as other City Commissioners that were not retired under the FRS and tried to find a possible solution for rectifying that situation.

VICE MAYOR ARSERIO questioned whether it only affected two City Commissioners.

CITY MANAGER CURTIS explained that both Commissioner Simone and Mayor Schwartz did not earn any sort of retirement benefit but the City had to make contributions of approximately 40% on their behalf to fund the entire system. He advised that the elected officials that were earning a retirement benefit with the FRS were not necessarily receiving 50% but that was the contribution rate that went into the system. He advised that there was recommendation to provide the difference in contribution rates which was approximately 10% in some form of a different retirement account, such as a 457.

MAYOR SCHWARTZ detailed historical events as to why she never received any contributions in the seven years she was entitled as a City Commissioner.

Discussion ensued

CONSENSUS was given by the City Commission to have City Manager Curtis and Interim City Attorney Tolces research the issue and bring the item back at a future meeting.

[Appendix A – Zoning – Section 3.3] Any representation made before any City Board, any Administrative Board, or the City Commission in the application for a variance, special exception, conditional use or request for any other permit shall be deemed a condition of the granting of the permit. Should any representation be false or should said representation not be continued as represented, same shall be deemed a violation of the permit and a violation of this section.
