Discussion ensued.

2) PUBLIC DISCUSSION

MARILYN A. KNEELAND, 7955 NW 5TH CT, represented Keep Margate Green and discussed a meeting on September 10th where they met with the owner of the Executive Golf Course, Mr. Fimiani.

JULIE JONES, 7871 NW 1ST STREET, thanked Interim City Attorney Tolces for

attending the 9/11 Memorial. She was disappointed to learn of Kodak Black's appearance at the Community Redevelopment Agency (CRA) Covered Sports Field event.

RICH ALIANIELLO, 7631 NW 23RD STREET, spoke about the demolished fire station on Rock Island Road.

JEAN E. KAPLAN, 601 NW 80TH AVENUE, ORIOLE GARDENS PHASE II referenced the golf course and keeping their space clean and green.

SUSAN HOFFMANN, ORIOLE GOLF & TENNIS PHASE II, 1030 COUNTRY CLUB DRIVE, complimented the new Covered Sports Field Complex. She referenced Keep Margate Green and discussed a recent meeting pertaining to the golf course. She questioned why sections of a nearby canal were never mowed.

CITY MANAGER CALE CURTIS explained that the canal was controlled by Coral Springs' Improvement District which was a Sunshine Water Control District. He confirmed that the City would make contact with them as both sides were not controlled by Margate.

EXECUTIVE GOLF COURSE OWNER, MIKE FIMIANI discussed continued misinformation being spread pertaining to the golf course and zoning change.

VICE MAYOR ANTONIO V. ARSERIO responded to Mr. Fimiani's comments.

ELSA J. SANCHEZ, 6930 NW 15TH STREET, heard that the Covered Sports Field was magnificent and she was unable to attend the CRA event. She questioned whose idea it was to invite rap artist, Kodak Black and read a statement opposing his attendance.

VICE MAYOR ARSERIO responded to Ms. Sanchez's comments.

COMMISSIONER TOMMY RUZZANO responded to Ms. Sanchez's comments.

Discussion ensued on Kodak Black's attendance.

LAUREN BERACHA, 6950 NW 14TH PLACE, suggested that the residents should vote on the City's Mayor and Vice Mayor positions.

JULI VAN DER MEULEN, 2913 NW 68 LN. discussed comments made on the golf course.

3) COMMISSION COMMENTS

COMMISSIONER ANTHONY N. CAGGIANO said that the hurricane season was entering its most active period and asked people to be alert and to stay safe.

COMMISSIONER JOANNE SIMONE congratulated Hispanic Americans for all their wonderful contributions for the City and Country. She referenced the color schemes of promotional material of City events and requested if these could be reviewed as they overshadowed the wording which made it difficult to read.

COMMISSIONER RUZZANO participated in the Dads and Donuts giveaway. He questioned the history behind the name of Chevy Chase's Plaza and whether it had a meaning or sentimental value.

Discussion ensued on the Chevy Chase Plaza.

COMMISSIONER RUZZANO indicated that he would like a dedicated day for walk-through permits such as roofs and air-conditioning swap outs and advised that he had already discussed this initiative with Building Director Richard Nixon. He found difficulties finding the Building Department's new software, Project Dox, on the website. He indicated that any form of remodeling in a house would require an update of all fire alarms and queried whether the owner could sign some form of affidavit as it was too costly to hire an electrician. He wished that they got rid of the Transit Oriented Corridor (TOC) when they were doing their Comprehensive Plan and referenced a failed housing development project on the south end of Margate.

COMMISSIONER SIMONE referenced the Project Dox software and said that she advised City Manager Curtis of a program which Oakland Park used called the Queless Electronic Scheduling system which had multiple functions.

COMMISSIONER RUZZANO wished Mayor Schwartz a Happy Birthday.

VICE MAYOR ARSERIO referenced Project Dox software and changing fire alarms and suggested that there should be a list of common things added to the software when pulling a permit, such as renovating a bathroom.

CITY MANAGER CURTIS advised that he could work with Building Director Nixon to put together frequently used applications and a check list that would help homeowners and contractors.

Discussion ensued on the suggested check list.

VICE MAYOR ARSERIO said that he would like to have a Review Board with maybe seven or nine members that consists of the City Commission, a few residents, contractors and people in Marketing depending on what they were reviewing. He indicated that the select group of people could report back to the Review Board. He proposed having some form of Review Committee to look at the City's website permitting and any other new software that was introduced to the City.

CITY MANAGER CURTIS said that he could review some best practices for that and report back to the City Commission on potential Committees for internal/external members or a combination of both.

VICE MAYOR ARSERIO appreciated input received from residents and discussed the CRA's Covered Sports Field event. He said that the CRA team did an incredible job and suggested small improvements that could be made. He said that he was still receiving complaints about the Charter School and asked City Manager Curtis if he was able to set up a meeting with Coral Springs.

CITY MANAGER CURTIS indicated that both he and Chief of Police Shaw experienced the traffic problems at Coral Bay. He advised that Chief of Police Shaw had been in communication with Coral Springs' Chief of Police, Clyde Perry but was yet to organize a meeting. He said that he would follow up with the Chief of Police Shaw to obtain a report.

VICE MAYOR ARSERIO referenced the Carolina Golf Course's Magistrate's hearing on September 28th and questioned if they were planning to do a quick evaluation prior to that meeting. He forewarned people against fake news, fake news groups and fake political action committees on social media sites and the internet, especially around election time. He provided his telephone number for residents to contact him if they had any

questions.

MAYOR ARLENE R. SCHWARTZ received complaints and made comments about the Carolina Golf Course's grass. She thanked Parks and Recreation and everyone else who was involved and attended last Saturday's CRA Covered Sports Complex event. She said the Spring Clean-up could possibly be held at that vicinity later in the year. She reminded everyone of October's Sounds at Sundown and wished a Happy 100th Birthday to Frank Gallaudet.

INTERIM CITY ATTORNEY TOLCES wished Mayor Schwartz a Happy Birthday and his office had been busy working with City staff on various development issues that were pending, notably Code Enforcement pertaining to Special Magistrates hearings. He thanked the City for the opportunity and said it was great to be here in Margate.

4) CITY MANAGER'S REPORT

CITY MANAGER CURTIS thanked Parks and Recreation and Communications and Marketing team for putting together the amazing grand opening event of the CRA's Covered Sports Field and advised that it was organized in less than 30 days.

VICE MAYOR ARSERIO highlighted the attraction of the Covered Sports Field and he informed that a couple of elected officials would like to take a tour of the facility.

CITY MANAGER CURTIS mentioned a Florida Recreation Development Assistance Program (FRDAP) grant of \$50,000 for additional shading at the Dog Park and said he would authorize Parks and Recreation Director, Mike Jones, to proceed unless the City Commission had any objection.

Discussion ensued on the type of shade covering.

The City Commission had no objection.

CITY MANAGER CURTIS highlighted that the Fall Festival would be on October 23rd at Margate Sports Complex. He said that September 26th would end the long time relationship with the City of Coconut Creek for Fire services and that they would be transitioning to their own department. He stated that Margate was not less safe and that they would continue to be fully covered for their operational needs. He said that there were 35 firefighters from Margate that would be transitioning to Coconut Creek. He publicly thanked them for their years of service at the City and read an email expressing his gratitude which he shared with the firefighters.

COMMISSIONER RUZZANO thanked City Manager Curtis for the update on the Fire Department. He wished the firefighters and Coconut Creek the best. He questioned when the pedestrian walkway on Winfield Boulevard Bridge would commence.

CITY MANAGER CURTIS confirmed that it was approved for design work but he would follow up with a status report.

Discussion ensued including having a garden club of some sort with reference to a design for Linear Park on Rock Island Road and tweaking the marketing.
