**BACKGROUND:** The City’s current contract with GLSC & Company, PLLC, approved by Resolution 12-486, expired upon completion of the September 30, 2015 audit. Pursuant to Florida Statute 218.391 - Auditor selection procedures, the Request for Proposal process was completed and responses reviewed by the selection committee.
