DBA BROWARD MEALS ON WHEELS (BMOW) AND THE NORTHWEST FOCAL POINT SENIOR CENTER DISTRICT- ADULT DAY CARE, TO PROVIDE NUTRITIONAL MEALS TO ELIGIBLE PARTICIPANTS OF THE ADULT DAY CARE, AGED SIXTY AND OVER, AND THEIR (UNPAID) CAREGIVERS AND PROGRAM VOLUNTEERS; PROVIDING FOR AN INTIAL ONE YEAR TERM; PROVIDING FOR AUTOMATIC RENEWAL; PROVIDING FOR TERMINATION.

**BACKGROUND:** Broward Meals on Wheels, is the sponsoring agency of the Senior Nutrition Program providing meals through the provisions of the Older American Act for Broward County residents. A prior agreement was approved on July 1, 2015 to provide nutritional meals to all persons age 60 and over at the Senior Center and included Adult Day Care participants. This agreement is been submitted for approval, at the request of Broward Meals on Wheels, to provide a separate agreement solely for the Adult Day Care participants.
