BACKGROUND: THE SITE PLAN FOR A NEW DOLLAR GENERAL WAS REVIEWED AT THE DRC MEETING ON JULY 28, 2015 AND THE COMMITTEE RECOMMENDED RE-SUBMITTAL BASED ON SUGGESTED REVISIONS. THE RE-SUBMITTAL WAS REVIEWED AT THE DRC ON SEPTEMBER 8, 2015 AT WHICH TIME THE PETITIONER ADVISED THAT THEY WOULD APPLY FOR A VARIANCE REQUEST. THEIR VARIANCE REQUEST WAS HEARD AT THE BOARD OF ADJUSTMENT MEETING ON OCTOBER 6, 2015 AND WAS TABLED UNTIL NOVEMBER 3RD.
