**BACKGROUND:** At the August 21st meeting, the Board repealed the CRA’s Purchasing and Procurement Policy and adopted the City’s Procurement Policy as provided in Ordinance 2107-12 by MCRA Resolution No. 533. The Board also directed the addition of language authorizing the Chair to approve agendas prior to publishing.

The CRA By Laws need to reflect these changes specifically to the following Articles;  
Article 2, Section 2.2 Chair  
Article 4, Section 4.3 Purchasing Procedures  
Article 5, Section 5.7 Maintenance and Disbursement of Funds.
