APPROVE A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING A MAINTENANCE MANAGEMENT AND FLEET RENTAL AGREEMENT, A FULL MAINTENANCE AGREEMENT AND A COMPANY OWNED VEHICLE SERVICE AGREEMENT WITH ENTERPRISE FLEET MANAGEMENT

**BACKGROUND:** On September 16, 2020, Resolution 20-074 authorized the City to enter into a Master Equity Lease Agreement and a Service Agreement with Enterprise FM Trust to address and achieve optimal vehicle replacement schedules. As part of the staff’s commitment to continued streamlined vehicle maintenance services for city owned vehicles and leased vehicles, staff is recommending entering into an agreement with Enterprise Fleet Management to provide vehicle maintenance options, as may be necessary, in order to address gaps in fleet vehicle maintenance due to attrition and as the needs arise.
