BACKGROUND: The City of Margate Building Department purchased a five-year software as a service agreement with Avolve Software Corporation for ProjectDox E-Plan. The Department of Environmental and Engineering Services (DEES) requires an additional module BIC workflow module for the Engineering Department for engineering permit and plan reviews. The amount of this additional model is \$63,550 in year one and \$7,800 in years 2 thru 5.
