APPROVING THE ACQUISITION OF A TRAINING SYSTEM FROM MEGGITT TRAINING SYSTEMS, INC. (MTSI); PROVIDING FOR GSA SCHEDULE GS-02F-0414D PRICING; DECLARING THE OUTDATED MEGGITT SYSTEM, INVENTORY CONTROL NO. 10990, AS SURPLUS TO THE NEEDS OF THE CITY; AUTHORIZING THE ADMINISTRATION TO UTILIZE THE OUTDATED MEGGITT SYSTEM AS A TRADE-IN TOWARD THE PURCHASE OF THE NEW SYSTEM; PROVIDING FOR A TRADE-IN VALUE OF \$9,483.00; PROVIDING FOR FUNDING FROM THE LAW ENFORCEMENT TRUST FUND IN AN AMOUNT NOT TO EXCEED \$32,000.

## **BACKGROUND:**

This upgraded system will be utilized for law enforcement purposes to continue to enhance the effectiveness of firearms and weapons training; and to facilitate reality based training without having to expose personnel to safety hazards. In addition, this simulator supplements live fire training by providing scenario based firearms proficiency without the expenditure of ammunition.

Our current Meggitt Training System is approximately six years old, and contains outdated software with antiquated scenarios. The proposed upgraded FATS 1.7 version offers more technological advancements to enhance training. The new system offers wireless control of the firearms and weapons devices, as opposed to tethered versions in our current system. Wireless weaponry will provide the student with more tactical cover, movement and concealment options. In addition to 400 pre-programmed scenarios, the FATS 1.7 version of the Meggitt System provides the user with the ability to create our own video scenarios filmed locally and an ability to upload them to the database. The FATS 1.7 version is compatible with our current weaponry, and we would not need to purchase any additional accessories.

We are requesting that the outdated Meggitt System (City Inventory Control #10990) be declared surplus to the needs of the City, and authorize the administration to utilize the surplus system as a trade-in, valued at \$9,483.00, toward the purchase of the new system.

The GSA pricing for the new system is \$41,292.00 and, minus the trade-in value of \$9,483.00 toward the purchase of the new system, the total cost to the City for this purchase is \$31,809.00. (Refer to attached quote from Meggitt - Note 7).

FISCAL IMPACT: Funded through the Law Enforcement Trust Fund Account.

**RECOMMENDATION:** Due to the law enforcement need for this equipment, and absent appropriate budgetary funds, the Chief of Police is respectfully requesting to fund this acquisition, via the Law Enforcement Trust Fund Account. This acquisition is an appropriate expenditure under permissible uses of equitable shared funds that are necessary to perform official law enforcement duties. The purchase amount is not to exceed \$32,000.
