A RESOLUTION OF THE BOARD OF THE NORTHWEST FOCAL POINT SENIOR CENTER DISTRICT, APPROVING AMENDMENT TO THE FISCAL YEAR 2014-2015 BUDGET. THE NORTHWEST FOCAL POINT SENIOR CENTER DISTRICT'S BUDGET SHALL AUTOMATICALLY BE ADJUSTED FOR ANY OUTSTANDING ENCUMBRANCES AS EVIDENCED BY AN AUTHORIZED PURCHASE ORDER, OR A FORMAL COMMITMENT BY THE BOARD, ISSUED PRIOR TO THE END OF THE FISCAL YEAR

BACKGROUND: The amendment to the Northwest Focal Point Senior Center District's Budget is to increase the budget by \$16,569.00. The 5310 FDOT Grant, awarded on May 12, 2015, requires a 10% match of the vehicle purchase price. The amount will be paid through a contribution from The Seniors Foundation of NW Broward, Inc.
