# RESOLUTION APPROVING THE AWARD OF BID NO. 2016-009 - HOLIDAY SPRINGS BOULEVARD MEDIAN IRRIGATION PROJECT TO SUPERIOR LANDSCAPING & LAWN SERVICE, INC., FOR THE PARKS & RECREATION DEPARTMENT; IN AN AMOUNT NOT TO EXCEED \$76,621.00

#### **BACKGROUND:**

The City advertised for bids for the Holiday Springs Boulevard Median Irrigation Project. A total of nine (9) bid packages were sent out and three (3) bids were received. The Parks & Recreation Department reviewed the bids submitted, and Superior Landscaping & Lawn Service, Inc. was determined to be the lowest responsive firm. Their total bid amount is \$76,621.00, which is inclusive of a \$5,000.00 contingency as required by the bid document for potential work related to unforeseen issues.

A copy of the bid tabulation and the bid award recommendation from the Parks & Recreation Department is attached.
