**BACKGROUND:** The petitioner is proposing to renovate an existing vacant building and to add a new addition of 3,100 square feet to develop a drive through Dandee Donut Factory and a drive through only kiosk ATM that is approximately 30 square feet plus drive aisle, in accordance with the petitioner's Site Plan. The zoning, Transit Oriented Corridor-Gateway, does not allow for drive through facilities without a Special Exception.
