BACKGROUND:

The Broward County Commission will be considering a possible compromise regarding the transportation/infrastructure

surtax proposals at a meeting on Wednesday, June 22. If a successful compromise with the cities is reached, the City Commission may rescind the previous infrastructure surtax resolution adopted by the City Commission and consider approval of the Interlocal Agreement that would be associated with the potential compromise.
