From 8:00 AM until 2:00 AM of the following day, Monday through Thursday; From 8:00 AM Friday until 4:00 AM the following Saturday; From 8:00 AM Saturday until 4:00 AM the following Sunday; From 12:00 Noon Sunday until 2:00 AM the following Monday; From 8:00 AM New Year's Eve until 4:00 AM on New Year's Day; From 8:00 AM St. Patrick's Day until 4:00 AM on March 18.
