**BACKGROUND:** The property owner, the Margate Community Redevelopment Agency (MCRA) owns the 1.534 acres vacant lot which is adjacent to the Margate Sports Complex. They are proposing the development of a covered sports field with walkways, a concession building and a restroom building on the lot.
