**BACKGROUND:** At the February 7, 2018 City Commission meeting, the Commission directed staff to make arrangements for free refreshments by Joji Yogurt and Dessert Bar, to be served at the Challenger Little League baseball program opening day, which occurs in conjunction with the City ribbon cutting ceremony for the opening of the new playground at the Margate Sports Complex.
