**BACKGROUND:** In response to the February 14, 2018 mass shooting at Marjory Stoneman Douglas High School in Parkland, Florida which killed 17 students, teachers and coaches and wounded 14 others, 5 with life-threatening injuries, as well as other mass shootings, the City Commission has expressed a desire to provide for a resolution urging State and Federal elected bodies to strengthen gun laws.

**RECOMMENDATION:** This is a base resolution, modeled on the City of Sunrise resolution, contains comprehensive options intended for the Commission to freely add or subtract text based upon open discussion at the City
