At the May 16, 2018 Commission Meeting, the City Commission voted to add to this Ordinance, the position of Assistant City Manager to the list of positions that the City Commission reserves to itself the power of appointment, suspension and removal. The City Commission approved first reading of this ordinance with a 3-2 vote on May 16, 2018.
