REVISING THE CITY OF MARGATE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) ANNUAL ACTION PLAN FOR FISCAL YEAR 2018; PROVIDING FOR ALLOCATING THE BALANCE OF FISCAL YEARS 2014 AND 2015 TO FISCAL YEAR 2018 TO BE USED FOR ESTABLISHED PROGRAM ACTIVITIES OF PURCHASE ASSISTANCE, HOUSING REHABILITATION AND ADMINISTRATION AND AMENDING THE 2015-2019 CONSOLIDATED PLAN TO PROVIDE CONSISTENCY WITH ACTION PLAN REVISIONS AND PRIORITY GOALS; PROVIDING FOR EFFECTIVE DATE.

BACKGROUND: In order to utilize established program activities for expending 2014 and 2015 fiscal year CDBG funds, it is necessary for the City to allocate the balance of those fiscal years to the 2018 action plan, revise the associated Action Plan, and include priority goals in the Consolidated Plan.

RECOMMENDATION: For approval.

FISCAL IMPACT: Transfer of balance of funds to be provided for in the 2019 budget amendment. No new fiscal impact.
