BACKGROUND:

The City advertised for bids and received three responses to Bid No. 2018-021 - Municipal Complex Elevators. The bids were carefully reviewed by the consultant hired to oversee the project; the consultant's recommendation is to award the base bid and all bid alternates to the lowest responsive, responsible bidder, Oracle Elevator Company. The Public Works Department concurs with the recommendation.
