#### **BACKGROUND:**

DEES is actively facilitating the conversion of existing water meter infrastructure to Automated Meter Reading (AMR) technology. The AMR conversion process has resulted in Staff's decision to standardize to water meters manufactured by Zenner Performance Meters, Inc. which are distributed in Florida exclusively by Fortiline Waterworks, Inc.

This request is for an approximate quantity of 400 Zenner 5/8 x 3/4 inch water meters at a unit cost of \$58.94 per meter.
