BACKGROUND: The contract with the Mellgren Planning Group (RFP 2018-022A) for the preparation of the Future Land Use Element of the City's comprehensive plan will expire June 2, 2020. The proposed second amendment to this contract will extend the expiration date out to January 27, 2021 as well as revise the scope of services to be provided with NO CHANGE TO CONTRACTED COMPENSATION. This amendment will repurpose funds dedicated to certain tasks in order for the contractor to successfully process the comprehensive plan amendment through all regulatory agencies.
