A RESOLUTION OF THE BOARD OF THE NORTHWEST FOCAL POINT SENIOR CENTER DISTRICT, APPROVING REFERRAL RATE AGREEMENT BETWEEN BROWARD COUNTY AND THE NORTHWEST FOCAL POINT SENIOR CENTER DISTRICT FOR COMMUNITY-BASED SERVICES FOR THE ELDERLY 22-EVSD-ADC-1440-01 TO PROVIDE ADULT DAYCARE SERVICES; PROVIDING FOR REIMBURSEMENT; PROVIDING FOR INITIAL ONE YEAR TERM AND TWO ADDITIONAL ONE-YEAR RENEWAL OPTION PERIODS; AUTHORIZING BOARD CHAIR AND PROJECT DIRECTOR TO RENEW THIS ANNUAL AGREEMENT UNDER THE SAME TERMS WITHOUT FURTHER BOARD ACTION; PROVIDING FOR AN EFFECTIVE DATE.

BACKGROUND: This agreement, 22-EVSD-ADC-1440-01, is the new Referral Rate Agreement with Broward County for the Community Care for the Elderly (CCE) funding of Adult Day Care Services. The agreement starts on July 1, 2021 and ends on June 30, 2022; with the option to renew for up to two (2) additional one-year periods. This agreement brings an increased reimbursement rate for services provided.
