**BACKGROUND:** Approval of Older American Act (OAA) 2022 contract. This funding source supports service programs provided at the Northwest Focal Point Senior Center. These services are mainly focused on in-person programs providing socialization, exercise and educational sessions, essential for the well-being and quality of life of older adults. As a result of the post pandemic dynamics, some service programs are different to accommodate the current senior's needs. Services will be provided in accordance with the terms and conditions outlined in the Master Contract JM020-08-2022. This contract, JA122-08-2022, will begin on January 1, 2022 and end on December 31, 2022.
