BACKGROUND: The applicant is seeking to rezone Margate Executive Golf Course from Recreational (S-1) to Multiple Dwelling (R-3) zoning district to construct 200 units. Applicant previously submitted an application to rezone the same property to Planned Unit Development (PUD), at the July 27, 2021 DRC meeting.
