BACKGROUND:

The City received fifteen (15) responses to Request for Qualifications (RFQ) 2023-010 - General Civil Engineering, Building Architectural, and Landscape Architectural Consulting Services. A Selection and Evaluation Committee (SEC) was formed to review, evaluate, and final rank the firms based on their submissions. The result of the SEC's final ranking

Staff requests permission to negotiate agreements, not to exceed five years per agreement, with the top ten ranked firms. In the event of impasse with one or more of the top ten ranked firms, Staff requests permission to engage in negotiations with the eleventh and successive ranked firm until agreements with no more than ten ranked firms are reached. The negotiated agreements will subsequently be presented to the City Commission for further action, up to and including award of the agreements.

RECOMMENDATION: Approve and authorize negotiations

FISCAL IMPACT: The City will not incur any costs until agreements are awarded and services are utilized for future projects based upon those agreements and budgeted capital improvement funding.
